For information: Her plans for the church include adult education. She also plans to leave the Sanctuary intact and available to the public for events such as weddings.

The sale price is \$275,000 with a \$25,000 deposit. The balance of \$250,000 net of adjustments will be due on closing.

The closing date has been set as October 1, 2019, which is consistent with the Trustees current estimate that it will take us that long to complete the process of severing the cemetery from the church and adjusting the zoning of the property on which the church sits.

# Report Submitted by Rodney Smith-Merkley, Minister for Respectful Relationship and Indigenous Justice

To begin, thank you to those elders whose term has ended with our inaugural meeting. This has been a challenging yet critical time of new beginnings. Thank you to those elders who will continue the work of building the church for today and tomorrow.

I was pleased with our inaugural meeting from my perspective. The land acknowledgement and Lorenzo Whetung's presentation seemed to go well. Since our meeting, Lorenzo's daughter Emily has been elected chief at Curve Lake, a 33-year-old lawyer and mother of two young boys. I hope to check in with Hiawatha and Alderville as they will have changed Chief and Council as well.

Dorothy Taylor's teaching also went well, at the early morning water blessing ceremony, as well as during our meeting. Dorothy will also be available on our "being good relations" day at Curve Lake on July 10. Thank you Gord for getting the poster on our website. I am hoping perhaps it could be sent out in the next few days as a direct email, as registration is around 15 at this point. We are hoping for 50 or 100 people. This initiative came in part from a request from the former Kawartha Highlands presbytery. They had sent monies to the region for this event, and I may need some budget for honorariums, and possibly a bus rental.

I attended Margaret Fisher's celebration of life service last Friday. Margaret was a very active part of dancing the circle of right relations action group. I continue to discern how will this work continues and begin anew within the region through networksand clusters.
