1:00 opened with worship, acknowledging the loss of Rev. D'thea Webster and her partner Maureen, we watched "Earth Song" by Frank Ticheli, which was sung at their funeral. Tom Smart read the call of Jeremiah and opened with prayer.

Began with general discussion around the role of the nominations team.

- 1) we will rewrite the expression of interest form. We have asked Diane Bosman for a copy of the form used for General Council vacancies. We wish to include questions around age in an appropriate way (eg please indicate whether you are under the age of 30) and gender (please provide pronouns you use to describe yourself.) Louise Slobodian is helping us with this.
- 2) The 2020 spring nominations process will be: March 2 nominations will begin to confirm openings with team chairs March 26 nominations will be open to receive expressions of interest *at some point when nominations are open, we will hold a webinar offering information about each team. This will require involvement from team chairs. April 16 deadline for submitting expression of interest April 23 (or there abouts) nominations will meet to discern placement of individuals May 1 the slate of names will be available for publication, to be received by the regional council at the spring meeting.
 3) In the spring nomination session we will receive expressions of interest for General Council
- 3) In the spring nomination session we will receive expressions of interest for General Council Commissioners, and present all the names of those who apply, with their background, to the regional council in anticipation of the spring meeting. Other than screen for eligibility, the Nominations Team will not be involved in selection of commissioners.
- 4) Nominations will be open in the spring, in anticipation of the spring meeting, and again following the autumn meeting for any business arising from that meeting. Expressions of interest will open between those times only at the request of a team chair, and only when incumbent team members are unable to complete their terms.

Evaluations of fall meeting

What worked well

Registration, Welcome, Worship, Gathering together, Discussion groups, Technology

Space worked well. Microphones and video screen worked well all in all, the facility was good for this meeting

Relatively brief worship time (appropriate for 1 day meeting), Remembrance video was excellent, efficient registration process with multiple tables, sufficient time for table groups to do their work, spacious lunch room.

Great venue. Very helpful, welcoming crew!

What could work better?

We simply need materials sooner.

We cannot have thoughtful and informed discussions if the Council has not had sufficient time to reflect on the material.

The manner in which it was all presented suggested that everything was already a done deal and our job was to approve it.

There was not a robust opportunity for input, and there was not a reasonable way to suggest significant alternatives because it felt like we had to approve everything in a dramatically compressed time line.

We want to be part of the conversation.

We are talkers.

If you don't give us sufficient opportunity to talk we'll either strive to take the time or check out of participation.

In the end, I fear we chose the latter.

I do not like leaving the voting on motions/proposals to the last hour of a long day. The pressure to be done and get home before falling asleep does not promote good decision making and is not respectful of the energy levels of the participants. It feels manipulative.

small groups: not just because meeting spaces were hard to find but because I had a sense that the decisions of our small group were not reflected in the feedback offered to the plenary session and subsequent decisions made by the regional council.

We were making quick decisions on policy matters that may require more discernment than this format can give.

Meeting material needs to be available at least 10 days prior to meeting; table group time should have been in the morning to give facilitators more time to address feedback before voting began; while being respectful of host church policy on food/drink in the sanctuary, it is not ideal for the "spirit" of the meeting to ban food/drink.

Having materials earlier would be helpful.

Suggestions:

Discuss. Share. Include. Consult. Make time and space. Build buy-in. Tell the story. Give the background. We desperately want to be included. We have much to offer if you'll allow us. Explain how you got to the place where you suggested the plan you wanted us to affirm. Look at the language above. It is all you/us. That is how it felt; how all regional governance has felt so far. This must be corrected, or this region will become siloed and disconnected. That is fundamentally antithetical to the culture of the predecessor Bay of Quinte Conference.

For multi-day meetings, consider a band for musical leadership.

More transparency in the process by which decisions of small groups and others are brought to the floor.

Consider having those matters requiring discussion and debate placed on the agenda for the morning session when people are generally more alert and do not as feel pressed for time as they do near the end of the day. Reduce the "service" part of the meeting to allow more time for conducting business. Try to enforce start times, breakout times, return from lunch time etc.

What else would you like to say?

I acknowledge that ECORC is a much larger body than the old Bay of Quinte Conference and therefore a larger host venue is needed to accommodate everybody.

The impact on rural churches in the north is obvious. It takes longer to travel therefore an earlier start in the day. It also costs to travel to distant urban venues. I traveled 397 km to Belleville and left home in the dark, moose and deer notwithstanding, travelling over two hours.

ECORC apparently decided in May that churches or pastoral charges would pay for lay representatives to attend as requested by their lay reps. They already pay for their clergyman to attend. It is not always possible for ride sharing.

With Rural Ministries cited as a 2020 ECORC priority the Assembly Of Elders should revisit the issue of travel expense for those over 100 km from the selected venue in the south. Many of the rural Communities of Faith are already struggling to pay their assessment fees set by DC.

If rural participation is encouraged then please encourage attendance in this material way.

With grateful appreciation

Since there's no where else to say this, the present configuration of the region is not what I voted for in moving from the two courts to one: the supervisory personnel are no nearer the local church than they were before and are, in fact, further away. I had thought the proposed model was to bring these personnel closer to those they serve by combining 3 or 4 presbyteries into a region, not by simply turning what used to be a conference into a region and then having the supervisory personnel working for 2 or 3 regions, and then having only one person working directly in the region. I'm disappointed that the decisions have been made to configure the regions in this way. There's not a darn thing I can do about this, but I feel betrayed by the church in this matter.

It was good to distribute photos from the meeting right afterwards.

<u>Planning notes for Regional Council meetings</u> <u>Louise's port-mortem reflections</u>

Overall:

There was a lot of confusion at Eastminster. Some of that was internal for sure. Some of that was us.

- who do we need to make sure is in the loop?
- be very clear about our info registration numbers, what the church is responsible for
- create simple written communication they can use internally? A contract??
- be clear about money what we're offering. Perhaps a standard rate?
- not go around the church staff even if we know the venue

- getting in the evening before was incredibly helpful
- •

Registration:

- 20 people didn't show but had committed to payment onsite. This was offset by some we hadn't expected.
- Payment options people changed their payment mode along the way
- Cheques written to ECORC instead of UCC
- 95% of attendees were eligible to vote so leaving voting cards to pick up at the desk was a good idea
- Keeping track of the money was harder than expected the registration staff wrote notes that were a godsend later
- Need ability to print / make new nametags or to have arranged with the church in advance access to their equipment
- Walk-ins likely to decrease as communication increases

- The caterers prepared for 200 (we had registered 170). We paid for 200.
- It was a long day. Was the food adequate?

- Marilyn Rodger provided coffee and tea for day and charged the RC. Just want to ensure the host church knows that in advance and so they don't bring in other supplies. Fairtrade is great, of course. That kind of thing can be part of the advance planning.

- Steward (count votes if needed)
- Small group leader

With that, we could also ask if they've done this before or would need coaching or training.

Do we want to keep a rolling list of general announcements / housekeeping to incorporate each time? Wifi (slide or poster)

Ending announcements

Nametags: Please tuck in string and return

Display tables:

We got requests in advance (fairtrade, UCW), one right before (Trish on giving) and one never asked but set up (books)

Let's know in advance our policy. Shall we say yes to any related request but have "rules" for the person or group? For example, we could ask them to close up after final break so that they are ready to leave when the event closes. Having a table pack up an hour after the conference was unexpected.
