Notes from Indigenous Justice and Respectful Relationship Working Group

Met by Zoom on Dec. 16, 19 from 2-3pm. Rodney Smith-Merkley, Sharon Hull, Helmut Enns, Elaine Kellogg. Regrets: Marilyn Fortin

Check-in and opening prayer.

- 1. Discussion around bringing a network together. 2 gatherings annually, one in Spring, one in fall. Potential to meet in between on-line, see who might be interested at first gathering? First gathering may be at Curve Lake Apr. 25th or May 2nd. A national staff person such as Lori Ransom can come and present on behalf of National Church program "Being Good Relations". Sharon will follow up with EDGE on sharing stories on-line through a youtube channel.
- 2. Rodney and Sharon plan to be involved at WAMPUM July 21-26. Some monies budgeted for recruiting? A year work plan submitted as a "Doing Mission Together" grant prior to April 15th. <u>Doing Mission Together Grant – Supporting Documents</u> Future Ministry and Vision for The United Church of Canada in Downtown Kingston

Background:

The congregations of Chalmers United Church and Sydenham Street United Church have a history reaching back across many decades, of worshiping together and sharing activities, which has inspired in many, a sense of common mission and purpose. After a lengthy consultation process, in June 2017 both congregations passed the following motion: **Moved** that Chalmers United Church and Sydenham Street United Church implement a model of shared ministry/staffing for the two congregations, with the aim of having a full joint ministry/staffing team in place by June 30, 2018 at the latest. At the time, we imagined that this model of cooperating in Ministry would be transformational for each congregation.

Progress:

In passing the motion it was agreed that Chalmers and Sydenham Street would remain autonomous congregations interested in sharing staff for shared worship services, having a joint choir and some shared mission activity. Each congregation continues to have its own governing body and budget. The model we are developing is one of cooperation in ministry, not amalgamation at this point.

In the fall of 2017, a Joint Search Committee was created to search for an Intentional Interim Minister to help us live into this new model of ministry. The congregations started to worship together in January 2018 and established joint committees for worship, finance and ministry and personnel. Worship leadership was coordinated by a joint Worship Committee from January to September 2018.

Coinciding with the appointment of Rev. Barry King as Intentional Interim Minister, in September 2018, a Transition Team, with equal representation from both congregations, was established to support and work with Rev. King during his ministry with us.

The Transition Team completed its first stage of communication with the members of both congregations to determine what members think and feel about Shared Ministry.

Next Stage:

In the second stage, the Transition Team plans to engage both congregations jointly in a process that will help to discern what we imagine for the future ministry and vision of The United Church of Canada in downtown Kingston. As an initial step, In June 2019, the Transition Team hosted a very successful Community Hub Round Table discussion with members of the wider community that surrounds both churches. The purpose of the discussion was to determine what the community's needs are and how the churches might address those needs. The next process in the second stage involves engaging an expert facilitator to help both congregations to define our compatible core values and determine what our future mission together might be working in a cooperative form of ministry.

Funding Request:

The Congregational Forums will take place on Sunday January 12, 2020 and Sunday January 19, 2020; both forums will be professionally facilitated by Kimberly Bain of Bain Group Consulting, Kingston Ontario. All members and adherents of both congregations are invited, and sessions will last 3 hours each from 9:30 am to 12:30 pm replacing the worship service. Because neither Chalmers United nor Sydenham Street United has a hall large enough to accommodate the expected number of participants (120) working in table groups, we are renting a hall in a hotel.

Total Budget:

January 10, 2020 Zoom teleconferencing

The cost of the rental of a hall to accommodate 120 people and provide refreshments for a break is \$2,573.15 per workshop. The fee for the facilitator is \$5,000.00 for both sessions. Sydenham Street United Church has an *Edge* transformation ministry grant that EDGE has approved to cover their expenses. Chalmers United Church is requesting \$5,000.00 to cover its half of the expenses.

Outcomes:

Both congregations look upon the sharing of services and cooperation in ministry as a way to live out our vision for ministry in downtown Kingston while retaining our congregational identities. These workshops are designed to define our core values and determine what our mission could/should be in the community going forward.

The **measurable change** will be a renewed commitment and enthusiasm for working together.
