In the formation of a new pastoral relationship and dependent on context, adequate practical experience and reflection opportunities may not be available the first six months of a new ministry. **CARRIED**

#### Young's Point

**2021-11-26\_018 MOTION** (I. Robb/B. Sheaves) That whereas East Central Ontario Regional Council has been receiving concerns regarding the Young's Point United Church since November 2020, from the Ministry and Personnel committee of the Lakefield Young's point pastoral charge, the minister, and also individual members regarding inappropriate treatment of the minister;

whereas the Young's Point United Church Board of Stewards have repeatedly contravened <u>The UCC</u> <u>Manual</u> B.7.7.4 b requiring specific attendance of the minister at meetings;

whereas treatment of the resident minister, the Pastoral Relations minister for East Central Ontario Regional Council and members of the Session has fallen below acceptable standards of the United Church of Canada as set out in the Workplace Discrimination, Harassment, and Violence Prevention and Response Policy (united-church.ca);

whereas the Board of Stewards endeavored to change the governance model of the congregation without having either a congregational meeting, nor the permission of the Regional Council;

whereas the Regional Council engaged *Credence & Co* to conduct a congregational assessment of the Young's Point congregation including widespread interviews with the congregation and a number of recommendations were made in a written Report which was subsequently approved by the Lakefield Young's point pastoral charge executive and apparently then rejected at Young's point, reflecting an unwillingness to participate in the next steps of dialogue and workshop and to undertake necessary change to function in accordance with the United Church polity;

whereas in September 2021 the Regional Council received a formal request from the Lakefield congregation to immediately change the boundaries of the Lakefield Young's Point Pastoral Charge, separating Lakefield from Young's point;

whereas the East Central Ontario Regional Council Assembly of Elders has received the determination of the Covenant Support Team, citing <u>UCC Manual 2021 section B2.1.9.b</u> that, having failed to meet the requirements to remain in good standing as a body of The United Church of Canada, the Covenant Support Team recommends that Young's Point United Church be closed permanently;

And whereas the East Central Ontario Regional Council Assembly of Elders recognizes that Young's Point United Church is entitled to respond to the proposed action,

Therefore, the East Central Ontario Regional Council Assembly of Elders is giving notice to Young's Point United Church that it will be considering a motion to disband.

Should members of the congregation choose to give a response, contact the Executive Minister by Tuesday, December 7, 2021. The Assembly of Elders will review the responses on December 10, 2021 before making its decision. **CARRIED**

- b) 10% to the Toronto United Church Council's Sustainable Energy Loan Fund.
- c) 20% be remitted to the Eastern Central Ontario Regional Council to support the Mission Strategy of the Regional Council.
- d) 20% be remitted to the United Church of Canada Mission and Support for on-going support of the ministry of the wider church.
- e) 40% be directed for purposes within The United Church of Canada, as recommend by the Community of Faith, and which is approved by the Regional Council before the disbanding of the Community of Faith. - 5. That the Four current Directors stand for another term in order to complete the transfer of funds and surrender of charter; namely Lyle Horn, Herman Stremler, Dawn Cox, and Mary Gordon be confirmed as Directors for the 2021-22 term, or until the surrender of the Council's charter. **CARRIED**

#### i) Formation, Nurture and Justice -

a) Team Progress report – Assembly of Elders representatives, Marilyn Fortin:

Work on a Guaranteed Livable Income (GLI) is going on locally and in all the regions.

ISARC - Susan said that she felt personally sick to see union leaders standing the Premier when he announced the \$15 minimum wage for 2022, years after \$15 would have moved wage-earners above the poverty line.

ISARC is also challenging Bill 37, which deals with Long-Term Care. The Ford Government appears to be ramming this through while ISARC has called for public hearings. She did not feel very optimistic about that demand.

Much work is being done in most regions to support the Palestinian people. The Canadian Shield Regional Council received a Proposal from members of Thunder Bay communities of faith to recommend to General Council that Israel be recognized as an apartheid state and that the plight of the Palestinian people be confronted.

Anti-Racism work is continuing. There is much work to be done at the national, regional, and local levels. There is concern about homelessness.

The Truth and Reconciliation Team is churning out really good work. There is some interest in ecotheology, and there is hope that the Care for Creation network would be working on that.

The Horseshoe Falls Region contains people who attended the Mohawk Institute, where searching of the grounds has begun. The question has been asked how the United Church might support Indigenous People as graves are found.

Most Regional Councils have been exploring and responding to the TRC Calls to Action.

Sharon stated, in regard to Affirming Ministries, that a network was being formed to support the process of becoming Affirming. There is a clergy support virtual meeting in East Central Ontario Region every week. They were thinking of supporting staff beyond their own region. She asked that the record reflect this desire.

GCO - Beth stated that a new Vision of Mission had been approved and that they were developing the Strategic Plan through to September 2022. This would include five objectives for the GCO. The Vision of Mission will be housed in the Regions

Purpose: The purpose of this policy is to clarify expectations of Communities of Faith regarding the				
sale of Church Property. The Manual C.2.6.				

#### Preamble

This document outlines the **Eastern Central Ontario Regional Council's** policy and best practices regarding the disposition of proceeds from the sale of congregational property and/or Investment and cash assets. It should be noted that properties being considered for sale must first be reviewed by the Mission Through Property of ECORC to assess whether said property might be a candidate for development by the UPRC. (United Property Resource Corporation)

#### Policy

### Not Disbanding

When Congregational property is being sold by a Community of Faith that is **not disbanding**, the following guidelines for the use of net proceeds from the sale:

a) 10% be remitted to the United Church of Canada for the on-going support of Indigenous Ministry. *This decision is about living into Reconciliation through our Indigenous ministry* 

b) 10% be remitted to the Eastern Central Ontario Regional Council to support the Mission Strategy of the Regional Council. - ECORC COF Assistance Fund

c) 10% be remitted to the United Church of Canada Mission and Support for on-going support of the ministry of the wider church.

d) 70% be retained by the Community of Faith with an approved ministry plan by the Regional Council for the use of the proceeds that is viable for sustaining the COF's ongoing Ministry and Outreach mission as stated in their Mission statement. *Communities of Faith can refer to Covenant Support Leadership and the Mission Through Property Teams*. The Regional Council will normally require that the remaining capital from the sale be protected / invested and that the Community of Faith be limited to drawing up to 5% of the value of the invested capital in any given year to support its operating budget. If the Community of Faith puts before the Regional Council a ministry plan, the Regional Council may allow the Community of Faith to use some or all of the remaining capital from the sale to implement the ministry plan. This may include capital expenses.

### <u>Disbanding</u>

When Congregational property is being sold by a Community of Faith that **is disbanding**, the following guidelines apply for the disposition of net proceeds from the sale:

a) 10% be remitted to the United Church of Canada for the on-going support of Indigenous Ministry. *This decision is about living into Reconciliation through our Indigenous ministry*.

b) 10% to the Toronto United Church Council's Sustainable Energy Loan Fund.

c) 20% be remitted to the Eastern Central Ontario Regional Council to support the Mission Strategy of the Regional Council. – ECORC COF Assistance Fund

d) 20% be remitted to the United Church of Canada Mission and Support for on-going support of the ministry of the wider church.

e) 40% be directed for purposes within The United Church of Canada, as recommend by the Community of Faith, and which is approved by the Regional Council before the disbanding of the Community of Faith. If a Community of Faith disbands without such a plan, it becomes the responsibility of the Regional Council to determine the disposition of the remaining funds.

### If the Congregational Property is a Manse please refer to the Manse Sale Policy

Note: Net proceeds means the amount left over after all expenses directly related to the sale of the property have been paid, e.g.: real estate fees, legal fees, cost of surveys and so on.

### The Manual 2021 section re:

### C.2.6 Property

The regional council is responsible for:

a) co-operating with the community of faith in buying, selling, leasing, and renovating community of faith property, and distributing any proceeds within denominational policies and guidelines, including

- making decisions on requests from communities of faith to buy, sell, mortgage, exchange, renovate, lease, or otherwise deal with community of faith property; The regional council makes decisions relating to the property of amalgamating congregations. See Congregational Life G.1.4.5.
- ii) making decisions on the meaning of the terms "other major assets" and "major renovations" for that regional council;

The terms "other major assets" and "major renovations" are explained in Congregational Life G.2.1.2 and G.2.1.3.

iii) communicating the meanings of those terms to each community of faith within the bounds served by the regional council; and

There are three exceptions to the regional council's responsibility for making decisions about the property of communities of faith that are congregations. They are set out in Congregational Life G.2.2.2, G.2.2.3, and G.2.2.4.

b) making decisions on the property of communities of faith remaining after the communities of faith cease to exist; and

c) buying, selling, leasing, and renovating regional property, and distributing any proceeds within denominational guidelines.

### Report, Retirees Forum (RF) for November 2021.

This has been a very busy month of activity for the RF and the RF leadership group which comprises Ian Robb, Caroline Giesbrecht, Ed Bentley, Elizabeth Macdonald, Judy MacGillivray, Bob LePage, Wayne Hilliker. We continue to keep Jean Wilson appraised of what is being discussed even though she has taken a sabbatical from this forum for now.

We intend to have two meetings per month. One meeting will be for the Leadership of the RF and the other will be The Retirees Network at which there will be an event structured to appeal to a wide audience.

Highlights of the month of November have been a very successful visit from Alan Hall, UC Pensions and Benefits administrator. Alan gave information and answered questions (where he was able) about the Pension Fund in 2022 moving forwards, its long-term viability, its ethical investments, and benefits as they applied to those eligible. We had about 30 + people in attendance by Zoom. Alan was prepared to speak with individuals on a personal basis and made that clear during the meeting (77 minutes) which was recorded and is available through Karen Wilson and the Newsletter.

We now have a list of Retired Ministers who have indicated their willingness to provide occasional Sunday supply where requested. The caveat for this work is that they are vaccinated, are affirming, and meet the Office of Vocations requirements for which we are grateful to Karen Valley's oversight. This list will be available from Caroline (rev.carolineg@xplornet.ca) on request. We also have the list from Carol Cunday (c.cunday@hotmail.com) of 28 named LLWL's who may also be available, and the distribution of this list remains to be decided.

These lists remain fluid, and we feel should be available through one person for each of the two streams of supply.

"Karen Wilson" has been very helpful with preparing certain tasks and advertising, none the least of which is the beginning of a private Facebook page accessible only initially by the leadership of the RF. There they can exchange views on a multitude of subjects without having to issue a formal email or Zoom invitation. We will see how this develops.

Karen Valley of the Office of Vocations will be with the RF on the 9th. December at 10.00 a.m. for a 60-minute discussion on the Office of Vocation ... its purposes etc. as well as a run-down on the HUB and how to get the best out of what it offers ministry personnel. We will advertise this through the newsletter and separately; hopefully having a large attendance. Ed Bentley has agreed to Moderate the event as he did so successfully with the previous Alan Hall event.

In January, on Thursday 13th. At 2.00 p.m. we have Rosemary Lambie and Paul Reed presenting a Q and A Zoom meeting on current regional structure of the United Church which has replaced the old Conference/Presbytery structure... its hopes/aims and its structure. This event will also be widely advertised with the hopes of participation from not only ECORC personnel but a wider audience. (We may have to increase our viewership capability from 100 persons +)

As Chair, Charles Barrett observed that the meeting would be a short one, beginning as it did at 10:05 am--"perhaps an hour and a half." Diane Matheson-Jimenez was the Zoom Host.

Participants were asked to introduce themselves and did so from east to west. Susan observed that she was attending as the ISARC representative—the Interfaith Social Assistance Reform Coalition.

Charles observed that Ernie had provided a record of the June 17th meeting and circulated it. No corrections were offered. Ernie agreed to keep the record again.

Charles observed that the customary order of the meeting was a survey of the Regions and their Councils. It was agreed that the presentations would be east to west again.

### **REPORTS FROM THE REGIONAL COUNCILS AND GCO**

#### Eastern Ontario Outaouais Regional Council

Charles did not have a written report but noted that Jane Dawson had moved to British Columbia – "we're working to fill big shoes!" He noted that volunteers were working in the Guaranteed Livable income Initiative, with the Bell's Corners community of faith being especially active. The Right Relations Circle was developing involvements with Indigenous People, and he had attended an event. A cluster was working to coordinate an outreach project. First United Church has been developing spiritual support for front line workers.

#### **East Central Ontario Regional Council**

Meggin reported that an Anti-Racism policy had been approved by the Annual General Meeting of the Regional Council and that the Anti-racism Interfaith Intercultural Forum was working on an action plan and measurable goals, starting with a survey to all communities of faith. A community workshop had been held in early October. The Guaranteed Livable Income Network had sponsored a number of gatherings. There is some interest in ecotheology, and she hoped that the Care for Creation network would be working on that.

Marilyn reported that they had organized a webinar sponsored by a number of churches with the Rev. Murray Pruden, who had spoken of the "United Nations of Canada." She found this view of the First Nations of Canada very exciting. The Indigenous Justice and Respectful Relations Forum is doing really good work and had held its first on-person meeting at Curve lake. (Charles observed that he was at his second home that morning, quite close to Curve Lake.) Charles also observed that the tendency of governments has been a "divide and conquer" policy.

Sharon noted that they had obtained a captioning program and hoped to have a webinar on this work soon. (Kapwing.com)

#### **Shining Waters Regional Council**

Jeffrey asked Tina to lead and she reported on a number of activities. The Annual General Meeting of the Regional Council met on November 13 and confirmed the Social and Ecological Justice Network. Two Proposals to General Council, one dealing with decriminalization of drug use and the other, with the plight of the Palestinian people, had been passed. Anti-Racism work is continuing, especially in the anti-Asian hate context. There is much work to be done at the national, regional, and local levels. There is concern about homelessness and the response of government to the resulting encampments. Work on a Guaranteed Livable Income (GLI) is going on locally. She expressed disgust with union leaders who stood with Premier Ford when he was announcing a \$15 minimum wage, several years after it represented a living wage. Right Relations work continues. Climate change impacts so many things. She concluded: "There's a lot of work to do!"

Jeffrey thanked Nina for her survey of activities. The Social and Ecological Justice Network had been made permanent by the Annual General Meeting, and its membership was renewed. The PalNet work is continuing and is being made available to others. He noted that the fifteen students employed during the summer--thanks to federal funding--had done a lot of interesting work. They had really focused concerns and produced some great videos. They were working on a website. He thanked Marg for her work, too!

Susan thanked Tina for her report and noted that the Guaranteed Livable Income Initiative was hard at work. The material produced for October 17 had been used by some churches. The focus was now on the provincial election next spring. And she thought that the Social and Ecological Justice Network needed people to focus on environmental issues.

Tina observed that she had joined the GLI vigil on April 8. She had also made a presentation at Bloor Street United Church on October 17. The MP for Davenport, Julie Dzerowicz, had proposed a Basic Income motion in the last Parliament, and Tina had urged her to continue the GLI work.

Charles commented on the discussion he and Ernie had been having as the meeting convened, which related to his having reviewed Stephanie Kelton's book, *The Deficit Myth: Modern Monetary Theory and the Birth of the People's Economy*, for the Rideau Book Club. The author is from a smaller American college, not one of the academic powerhouses, but she is focused on the possibility of guaranteed employment, a "cousin" of the Guaranteed Livable Income. The book is somewhat polemical in nature but well worth reading.

Ernie responded with observations on the legislating of full employment as a goal at the end of the Second World War in the United States, but the conviction of the Rt. Hon. C.D. Howe, then MP for one of the Lakehead ridings and "Minister of Everything," that re-conversion to peacetime production of Canadian industry and the meeting of postwar consumer demand would lead to full employment—which was largely true for a dozen years after the war. The challenge of inflation, as the Seventies began, led the first Trudeau government into a preoccupation with the value of the dollar--rather than full employment--and Canadians have been cursed by that bias ever since. Tom Kent, a leading intellectual figure in the Pearson Government, in fact resigned as Deputy Minister of Regional Economic Expansion in February 1971 and went to Nova Scotia because he was convinced that his vision of full employment could not be achieved under the Trudeau government.

#### **Canadian Shield Regional Council**

Ernie and Melody had prepared a written report: The Canadian Shield Regional Council is coming to grips with the social justice challenges the communities of faith and their members face across our vast region. This report is based on the perspectives of Ernie Epp, who used to represent the Christian Outreach and Social Action Committee of Cambrian Presbytery, Conference of Manitoba and Northwestern Ontario, on the SJNOR and Melody Duncanson-Hales, who has joined the SJNOR as Minister for Congregational Support, Stewardship, Youth, Mission and Justice of the Canadian Shield Regional Council. Ernie lives in Thunder Bay, and Melody lives in Sudbury. While our current perspectives are urban ones, at the west and east ends of the Canadian Shield Region respectively, Melody has a strong rural background with a specialist in rural ministry and Ernie grew up on a farm in Manitoba

The constitution of the Canadian Shield Regional Council includes two commissions—one of them Support to Communities of Faith and the other, the Pastoral Relations one. The former includes social justice work through the Affirming Ministry Resource Team and the Right Relations Resource Team. The Annual Meeting held on 16 October 2021 celebrated the fact that the Regional Council has been accepted as an Affirming Ministry. The Annual Meeting was also briefed by Sara Stratton on the development of the National Indigenous Council and National Elders Council and the development of relations between our Indigenous brothers and sisters in their several organizations and the various Regional Councils to which each might relate. Sara pointed to the continuing operation of the Healing Fund, and she noted that the next deadline for applications to the Justice and Reconciliation Fund is in March 2022.

One of the workshops, led by the Right Rev. Richard Bott, explored the path "From Reconciliation to Reparations." Those in attendance contemplated the 1986 Apology given at Laurentian University in Sudbury, the Truth and Reconciliation Commission appointed by the Federal Government, and the 2006 settlement agreement, which has become current in the context of the finding of unmarked graves of Indigenous children who attended residential schools in decades past. The Moderator spoke to the response of the United Church to the findings at Kamloops with four days of prayer and mourning. More action Is needed, and participants in the workshop discussed what they should do.

The Annual Meeting had also received a Proposal from members of Thunder Bay communities of faith to recommend to General Council that Israel be recognized as an apartheid state and that the plight of the Palestinian people be confronted. The Annual Meeting referred this to the Regional Council Executive, which convened a Town Hall by Zoom on 26 October to receive input on the Proposal. Lively discussion occurred in this Town Hall, and the Executive passed on the Proposal with concurrence.

There is a real challenge for communities of faith in the Canadian Shield Region to move beyond work by various communities and volunteers within these communities. Ernie notes the activity for a number of years of the Interfaith Refugee Committee in Thunder Bay. A number of churches are active in supporting food banks, such as the Regional Food Distribution Agency, the Rotary Shelter House, and the Dew Drop Inn "soup kitchen" operated by St. Andrew's RC Church. Ernie has also been active in Poverty Free Thunder Bay, which carried on a vigorous Fare Free Transit Campaign in 2020, after City Council suspended transit fares for a time early in the pandemic. Ernie is also involved with the Guaranteed Livable Income Campaign, which has been inspired by former Moderator, the Very Rev. Lois Wilson, and is pushing the effort from coast to coast. A retired Ontario public servant, Frank Wilson, has been keeping GLI concerns before the city through Diversity Thunder Bay and Poverty Free Thunder Bay.

Melody pointed to activities throughout northeastern Ontario, where communities of faith continue to support food security and anti-poverty initiatives. These include partnerships with food banks, support services and wellness outreach work. In Sudbury, the Downtown Churches group is advocating with the City of Greater Sudbury to provide sustainable housing supports for those living in encampments. In Timmins, Mountjoy United Church continues to deepen partnership with Project Love, a meal sharing program. In North Bay, churches work together to support the Loaves and Fishes food bank. While many of these initiatives are charitable in nature, the advocacy and relationship building invites proactive justice work.

North Bay Mission Cluster continues their collective work engaging with the United Church faith community. They have been successful in a number of social justice initiatives such as workshops addressing micro-aggression, webinar series connecting Indigenous rights and climate action, with speakers from the Wet'suwet'en nation, offering leadership to the "Give it Up For Earth" campaign, and support for churches engaging with the Blue Umbrella program offered by the Alzheimer's Society of Canada.

On Manitoulin Island, United Church congregations joined together with local KAIROS members to create outdoor displays recognizing the history and impact of residential schools. This work continues to evolve with planned KAIROS Blanket Exercise workshops when pandemic restrictions allow for larger group gatherings.

Manitou Intentional Learning Community, a network of learners originating from Sudbury area and building across northern Ontario, has hosted a number of educational workshops and conversations addressing social justice issues and concerns, in particular in partnership with the Right Relations Resource Team from Canadian Shield Regional Council. The most recent opportunity, offered last month, focused on the UN Declaration of the Rights of Indigenous Peoples.

The Right Relations Resource Team also continues to offer leadership throughout Canadian Shield Region. They are developing a social media presence, and they have produced a number of videos and reflections suitable for both online and in-person worship to deepen engagement in reconciliation and action.

Ernie has also been concerned about the plight of the Palestinian people, with support for Independent Jewish Voices-Canada important in his thinking. Webinars organized by IJV-Canada, the American Friends Service Committee, the United Network for Justice and Peace in Palestine and Israel, and the Society for Socialist

Studies—among others—have been deeply informative. These webinars and books inform his own work on a book, On Seeking God's Will for Palestine and Israel.

All who participated in the KAIROS Twenty Years of Spirited Action for Justice in the last week of October had the opportunity to learn about the plight of people--especially in Guatemala--impacted by Canadian mining companies and to be reminded of the labours of the Canadian Network for Corporate Accountability to achieve an ombudsperson to act on complaints against these companies from people hurt by them. (Ernie and Melody first met at the gathering at Church House in 2013 that led to the organization of United for Mining Justice, which supports the work of the Canadian Network for Corporate Accountability.)

#### The Three Western Ontario Regions

Diane noted a couple of items not included in the meeting agenda, namely, a provincial election focus with the possibility of a January meeting, and the new mission statement of the United Church of Canada. She thought it would be useful to spend some time unpacking that document.

Work since the last SJNOR meeting in the three Regions included their all becoming Affirming Ministries and supporting a priest who has been excommunicated for conducting a same sex marriage. Anti-Racism work has been carried on in virtual gatherings.

Diane mentioned the book by Carol Kilby, *Evolutionary Dancer*, which offers some rituals for our environmental plight. The author will be at a church in Welland on Earth Day 2022. In anticipation of Lent, she pointed to rituals for the season in "Coming out of Exile."

Diane noted that the Horseshoe Falls Region contains people who attended the Mohawk Institute, where searching of the grounds has begun. She asked how the United Church might support Indigenous People as graves are found.

Lastly, she noted that Long Term Care homes have been a source of crisis during the COVID-19 pandemic and suggested that this would be focused for the Provincial Election next spring.

Charles observed that his community of faith is an Affirming Ministry and that other groups use the church building, too. One applicant is an Anabaptist fellowship, and he wondered how they stood on the Affirming Ministry principles. Ernie responded by noting his own Mennonite background and his subscription to Anabaptist World, an internet journal, from which he has observed discussion towards a favourable resolution on LGBTQ2S matters among Mennonite Brethren people in Canada and within Mennonite Church USA. So the Ottawa fellowship might agree with the Affirming Ministry principles. Charles responded, "We hope so!"

Thérèse spoke to the other half of Western Right Relations work. After the graves were found at Kamloops, a vigil was organized on July 1 and more than 250 people attended. They were Indigenous and non-Indigenous people and gathered under the rubric, "Together in Prayer." They had held a second vigil on November 1—All Saints Day—under the rubric, "Together in Song." Art and food were part of these gatherings. On-line gatherings were first of all of Indigenous and non-Indigenous people, secondly of Indigenous people involved in United Church outreach, and thirdly of non-Indigenous and Indigenous people active in Right Relations work. Some good connections had come out of this activity.

Thérèse also stated that the Antler River Watershed Regional Council has been responding to the TRC Calls to Action and has hosted three of four sessions already. There are fifty registrants exploring the Calls to Action.

The United Church of Canada L'Église Unie du Canada East Central Ontario Regional Council Meeting of the Assembly of Elders

Thérèse spoke of the Affirming Ministry work in which LGBTQ2S people were being welcomed and support was being provided for staff needs. She referred to a specific group and wondered if it would continue and asked, "how might it continue."

Sharon stated, in regard to Affirming Ministries, that a network was being formed to support the process of becoming Affirming and to encourage communities of faith to continue on their journey—create and update action plans—ongoing learning and focus. There is a clergy support virtual meeting in East Central Ontario Region every week. There was wondering about also having a clergy support virtual gathering for 2SLGBT+ clergy, perhaps once a month or every other month. Hearing Thérèse speak, Sharon wondered if a group for clergy/staff across Ontario would be a good idea.

Marg said, in following up on what Thérèse had said, that there was a **sharing circle in ???** in which Gloria Cook, who served at one time in the GCO, was active. She also mentioned "Nations Uniting" as a community of faith in the Grand River area among United Church people.

### ISARC

Susan raised the matter of the support that the Social Justice Network has customarily offered ISARC, which did not appear in the record of the June 17 meeting. Ernie suggested that it might be in the record of the earlier meeting.

Susan then pointed to the upcoming Religious Leaders Forum on November 24 and expressed regret that this interfaith gathering would not occur at Queen's Park. "It is a pre-election gathering, and many MPPs have appeared at previous gatherings in the period before a provincial election!"

This year's gathering will focus on housing. The plenary will be led by Ricardo Tranjan, senior researcher for the Canadian Centre for Policy Alternatives, with a theological reflection by Rabbi Yael Splansky, Senior Rabbi of Holy Blossom Temple and President of the Toronto Board of Rabbis.

Break-out rooms will cover several themes with fine speakers including:

Sandra Caleta, leader of Advocates for Long-Term Care Ontario,

Natalie Mehra, Executive Director, Ontario Health Coalition,

Douglas Kwan, Director of Advocacy and Legal Services, Advocacy Centre for Tenants Ontario,

Jennifer VanGennip, Co-chair of the Ontario Alliance to End Homelessness and Chair, Simcoe County Alliance to End Homelessness Barrie Chapter, and

Laura Cattari, Senior Policy Analyst at Hamilton Roundtable for Poverty Reduction.

Susan described this as an engaging three hours of learning and advocacy.

Susan also said that ISARC is pushing the Guaranteed Livable Income—"it is doable!" They are also pushing for an increase in the shelter allowance for people on social assistance

Susan noted two policy papers worth consulting:

Building a Strong Foundation—an Ontario Government document, which follows on a bad history of pushing people into employment and off social assistance

Ontario Government Housing and Homelessness report, which appears designed to reduce social housing

ISARC is also challenging Bill 37, which deals with Long-Term Care. The Ford Government appears to be ramming this through while ISARC has called for public hearings. She did not feel very optimistic about that demand.

Susan also said that she felt personally sick to see union leaders standing the Premier when he announced the \$15 minimum wage for 2022, years after \$15 would have moved wage-earners above the poverty line.

#### **GENERAL COUNCIL OFFICE**

Beth noted that a new Mission statement had been approved by the 43<sup>rd</sup> General Council: Deep spirituality Bold discipleship Daring justice

The Vision of The United Church of Canada as approved by the 43<sup>rd</sup> General Council at its meeting on Saturday, 23 October 2021 reads as follows:

"Called by God, as disciples of Jesus, the United Church of Canada seeks to be a bold, connected, evolving church of diverse, courageous, hope-filled communities united in deep spirituality, inspiring worship, and daring justice."

The Strategic Plan which will run to GC45 in 2025 is being developed. From now until September 2022 there will be the development of both strategic and operational plans. This includes five objectives for GCO staff work. A super year September 2022-December 2023 is being planned. Staffing is being developed in meetings chaired by Jennifer Henry, with an Executive Minister for each strategic focus. The Vision and Mission will hopefully be implemented in the Regions, too.

Church in Mission hosted the Engage Love and Justice conference November 3 to 7. All of the sessions were recorded and can be accessed for six months. Watch out for communications that share details on how to access those sessions. Several of you participated. Thanks!

As regards LGBTQ2S matters, Beth observed that the Office of Vocations with Adam Hanley's leadership has done some preliminary work relating to ministry personnel when Jordan Sullivan was still on staff. She was not sure of the status ow..

Among recent exciting activities, Beth noted:

UCCan COP26, which had produced a host of postings reflective of the views of For Love of Creation: "This is a really great blog!" l

Charles complimented Beth for her presentation—"a real tour de force!"—and recognized what she and Lori Neale had been doing at the General Council Office

Tina asked whether there was work going on in regard to the World Day of Prayer for Unity 2002 and said that she knew some people who would like to work on that. Beth responded that she would meet with the leadership of Justice and Peace in regard to this request.

### ISARC

Charles raised the matter of the annual donation to ISARC, and Ernie suggested that it might have been passed at an earlier meeting and promised to check the minutes. [He did so later and discovered that the donation was customarily made at the November meeting. Unfortunately, the meeting did not have a financial report on which to base a motion.]

Sharon suggested that a resolution might be passed, just to be sure about support.

Charles offered to check with the GCO on the SJNOR account and the state of requests to the Regional Councils of Ontario for their support. Susan wondered whether Will Kunder, who had retired from the SJNOR, might resume the Treasurership—"after his wedding!" She thought that financial information was needed before a motion was made. Charles said that he would be happy to reach out to Will on these matters. Marg thought that Will could serve for a year and train a successor. Melody suggested that she had worked with Will and had the links—"I could be trained!"

Charles raised the matter of how to interface regarding the next Provincial Election. A conference call early in the New Year could open the way to a planning session. Ernie noted the email Charles had sent out on June 17 suggesting two tasks, one the development of an economic policy paper and the other, the drafting of a theological statement. Charles responded: "we could do these things."

Charles thanked everyone for a rich discussion.

Sharon suggested that the mandate of the Social Justice Network of the Ontario Regions should be reconsidered in light of the new Vision Statement. Susan concluded the meeting with a closing prayer. Respectfully submitted, Ernie Epp, Recorder
