Reports

Assembly of Elders

In 2022 there were Endings and beginnings!

We grieved with and for David as we released him from his ministry with the Regional Council. His good cheer and sense of humour were and are and will continue to be missed. Our grief continued during the deterioration of his health and upon his death, but we were strengthened by the courage and confidence of his faith.

We were stunned by the announcement that Rosemary would depart the role of Executive Minister in October. David and Rosemary had been guiding forces through the days of restructuring and through the uncertain days of mandated closure of buildings and working from a distance. That too was ending this past year and we needed to find new ways of being. Pastoral Relations Ministry began again when Darren joined us in July and We encountered the new at the beginning of Eric's ministry in January 2023.

The role of the Assembly of Elders is to receive the reports and recommended action from the Leadership Teams and that it did monthly at regular meetings throughout the year. The year however was far from regular for East Central Ontario Regional Council. It is when the Leadership Team's encounter that which is not routine the Assembly of Elders are called upon to take a multidiscipline approach balancing needs and concerns of ministry personnel, communities of faith and property matters. The fullness of the work of the Assembly of Elders is contained in the recorded Minutes contained in this workbook.

Going Forward

A review of our meeting practices indicates that there is a growing comfort and appreciation for online gatherings for the purpose of sharing education opportunities, in depth conversations and routine business. The practice of online gatherings before the Spring and fall meetings will continue. It was also heard that there are rich benefits of in-person gathering. The intent shall be to provide spring and fall gatherings of a hybrid nature ensuring opportunity for participation by choice but structured so those in person have time for interaction with the displays and resources and opportunity to build relationships with one another.

It is increasing evident that the work of Pastoral Relations, support of Ministry Personnel, and visioning with communities of faith is beyond the capacity of our current staffing component. Less clear is whether the established budget line sufficient to support a half time position is sustainable with the current funding model to support a call or whether the needed support is better acquired with an appointment or multiple contracts as required. It remains to be determined the scope and direction of this role and the required skill set. These questions need to be resolved and the Assembly of Elders with the Covenant Support Team will be attempted to do so.

With the aid of Nominations, the Assembly of Elders has commitment to strategic planning with the establishment of a term Forum that will guide the Regional Council through a process beginning with the 2023 Spring Meeting of the Regional Council and proceeding through the year. The work will not lose sight of our vision and priorities but will offer ways to respond to and participate in the denomination's Call and Vision to Deep Spirituality Bold Discipleship and Daring Justice.

Over the past few years as individuals have become more comfortable in the various roles the flexibility and focus capability of our organizational structure becomes apparent but at the same time questions and circumstances have identified missing policies and uncertainty. An organizational structure may inhibit or enable but success is always dependent on the leadership and people. That said, there was a commitment upon the introduction of the regional council to review our structure after five years. That review work is slated to begin this year.

Three years ago, Don McLean, Ian Robb, and Kathlyn Whyte joined the Assembly of Elders. Don departed our circle following a change of Pastoral Relations and his relocation outside of our regional council; Ian departed over the winter to direct his ministry to the support of those receiving organ transplants; Kathlyn ends her term at the rise of our Spring meeting and enters the Candidacy pathway. We take this opportunity to thank them for their service and to wish them well in future endeavours.

Executive Minister

Firstly, I want to thank all those who have welcomed me with such warmth into my new role as the Executive Minister. While the learning curve has been particularly steep for me in the East Central Ontario Regional Council, I have witnessed much grace and patience as I've navigated the geography and meeting so many new people.

I was able to see a number of communities of faith in the last few months for meetings, leading worship or just visiting to get to know them. It's a diverse council with many gifts and much creativity. I'm looking forward to continuing to explore, plan and meet with as many of you as possible.

With a group of almost 500 communities of faith throughout my three regional councils, I am obviously not going to be able to see them all, but all of them are important points of connection with their broader communities. Remembering that connection reminds us that we are more than just the number of members who sit in our pews on a Sunday morning. I am conscious of that far wider reach that each of us has, and the potential for impact that this represents for all of us.

I like to remind folks that the Regional Council is not separate from the communities of faith... it is us. The communities of faith ARE the ECORC. We are there to support each other, navigate challenges we face and build ministry together. The Regional Council doesn't exist for its own purposes, doesn't have an independent membership. When we create structures or make decisions, we need to be reminded that our grounding purpose is to support the public manifestations of the United Church of Canada within our geographic boundaries: the communities of faith themselves.

Apart from "learning the ropes", a newbie like me has lots of questions about why we do things the way that we do. I also come with a large number of ideas for ways we can change things for efficiency and focus, but mostly to ensure that our gifts can be put to effective use in the ways we are called by God. It is my sincerest hope that we can continue to evolve and strengthen this church of ours in the coming years.

Another piece of work that ECORC has launched is around strategic planning for the Regional Council. As you may have noticed, I'm actually quite passionate about this. Inspired by the work that the General Council has done and the work done by ECORC on its own vision and mission statements, I'm looking forward to establishing a work plan that addresses some key areas of work for us going forward. A new team has been established for this purpose, will be consulting with you in the coming months and hopes to have a clear plan ready for the end of this year.

I continue to be involved in carrying out the decisions of the Assembly of Elders and the wider Regional Council. I work with staff to ensure that pastoral relations, archives, communications, ministry support, finance and property issues, etc. are carried out according to the decisions we make together.

Mid 2023 Financial Update

The ECORC finances are overseen by the Mission Through Property and Finance Team who prepare the budget based on input from the various teams. The 2023 budget was approved by the Assembly of Elders and presented to the Regional Council members at the 2022 fall meeting. The funding for the Regional Council comes from the General Council Office which determines the funding available for the year. The 2023 funding for Administration at \$325,000 plus some cross regions support funds which cover part of the Executive Minister expenses for a total of \$392,000. The funding for Mission activities remained at the reduced 2022 level of \$240,000. We budgeted for an Administrative budget deficit of \$60,296 and a Mission deficit of \$31,849.

The year-to-date administrative income is slightly ahead of budget due to accrued archive grant and designated gifts. The Mission Support income is above budget due to property sales but transfers for grants is below budget as the grants are paid quarterly and the funds are transferred after grants have been issued and other activities charged.

Staff expenses are below budget primarily due to minimal travel and associated costs this year, most quarterly invoices have not been received, also a special care minister has been budgeted but not hired. Regional Networks, Retires Forum, Regional Council AGM, and Pastoral Relations are below budget again due to minimal travel and the extensive use of Zoom virtual meetings. Administrative services are below budget due to some areas not being charged in the first quarter.

The mission support grants are slightly lower than budget as the Quo-Mo-Lac grant single payment is paid in the second quarter. Doing Mission Together grants for 2023 have yet to be paid.

Overall, we are showing an Administrative surplus of \$43,618 to the end of March and a Mission surplus of \$17,563. As invoices for various administrative services come in the surplus will be reduced and the Mission surplus will decrease towards the budgeted amount.

The funds from church property sales are increasing and will be used to support communities of faith through grants, loans and emergency support. This will be handled through the Community of Faith Assistance Fund which is being set up with Toronto United Church Council (TUCC).

Regional Council Assets at the end of March

Bank Account: \$1,832,925.

United Church Foundation: \$791,386 (lower than last March due to poor market performance.)

The reviewed 2021 financial report is included for information.

Communications and Administration Assistant

The Communication and Administration Assistant's focus is to expand community engagement and connections, particularly (but not exclusively) through use of the ECORC website, social media platforms and internal & external publications. This position also responds to general inquiries to the ECORC.

This past year I feel I have continued to grow in my role but I have also become more confident as I continue to learn. Here are some of my accomplishments:

- In July of 2022, my role expanded to include supporting the Equity team and the captioning of regional videos for our YouTube channel. The platform I use is called Filmora which is an editing software allowing me to edit and caption our videos. For those sending me videos, it helps to include a script if you're able as well as contact information for any questions I may have. I would like to say thank you to Phil Wilson for helping me navigate and learn Filmora and to the Equity Team for such a warm welcome!
- Working with Deb Fortin-Brown, we created a logo for our Equity Team. For those who attended our Fall Meeting, you would have seen it on the pink t-shirts I created for our Equity Support Persons. Thank you, Deb, for your inspiration and for working with me to bring the logo to life!
- ➤ I continue to work with the Regional Teams, Forums, and Networks to ensure our website is as up to date as possible, containing pertinent information. I appreciate the efforts of everyone involved in this ongoing work.
- My Communications colleagues in Eastern Ontario Outaouais and Nakonha:ka Regional Councils continue to meet on a monthly basis and we now meet bi-monthly with our Executive Minister, Rev. Éric Hébert-Daly for a Communication's Staff Meeting
- ➤ I continue being a part of the Facilitation Team as well as the Tech Team for our Regional Meetings and Information Sessions as well as setting up the registration forms and event pages. More events are being held around our Regional Council and I encourage people to use the "Submit Your Own Event" form which I will be producing a video tutorial for in the coming months.
- This past fall we held our first hybrid meeting which was a huge success considering it was the first time we have hosted one but also the first in person meeting since 2019. I look forward too many more in-person (and hybrid) meetings. I really enjoyed meeting so many of you in person!

- Recently a decision was made to switch to a new newsletter platform called "Envoke" which is Canadian based and is proving to be quite user friendly. We have added a "Pastoral Relations" newsletter which will arrive in your inbox bi-monthly and you will see other stand-alone newsletters coming from Teams as needed to share their news and events.
- I have attended many training sessions as well as an online conference hosted by Axe-Con Digital Accessibility.
- > Social Media- Our private Facebook group continues to grow and I have been focusing on our main Facebook page as well and Instagram.

Again, I would like to say thank you to all of you for your continued support and I look forward to what this next year has to offer us.

Each year the Nominations Team begins discerning the current year's needs by reaching out to team chairs, confirming team membership and who will be concluding their terms, along with what skills or gifts the team might be looking for to assist in its work for the coming years.

We do our best to bring questions of equity to each team by asking: is there a diversity of voices represented, are there people from different geographical regions, different offices within the church (ordered, lay etc), a diversity of backgrounds and gifts? This year the considerations of equity and diversity have been difficult. There were very few people who put their names forward for various teams. And several of the teams are not what one would call diverse. Nominations is one of those teams. We have a team made predominantly of ordained ministers, and most of those are people who identify as female. Other teams have similar situations. Formation, Nurture and Justice is only those who identify as female. No one else expressed an interest. Mission Through Property is predominantly lay people who identify as male. While there is slightly better diversity on other teams, it is difficult to create it when people are not volunteering to take part.

The Nominations Team would like to encourage everyone to consider taking part in the work of the Region. Some teams require more time and commitment than others. Each team has a different focus and offers the opportunity to work on particular projects and interests. This report includes the full list of each team's membership. Speak to anyone you know on a team about the work they are doing. See if there is something you might find energizing and fulfilling.

Our team spends the time to read, pray and consider who, from the expressions of interest forms would best fit within the context of the teams they want to serve. We had two meetings this year to deal with filling positions. The first meeting dealt exclusively with the Strategic Planning Working Group. Using the criteria set out for the Nominations Team we looked at those who expressed interest and recommended as diverse a group of people as possible from those who were interested. As with much of our process, we found that certain voices were missing.

The experience with the Strategic Planning Working Group has led the Nominations Team to believe that a process needs to be put in place to address the needs of developing membership for these ad hoc types of groups. Again, any time we attempt to fill positions on teams and groups, we find some voices are 'not at the table'. We encourage more people from the northern and eastern parts of our Region and from various under represented gender identities and groups to put themselves forward so as to offer more fulsome conversations and considerations for our teams.

Our Region is blessed by those who have offered themselves to the work of the Regional Council. There are a variety of gifts and skills in our midst. Thank you to those who have offered themselves to the work of our teams. The Nominations Team prays each person in the Region will consider how they could serve in the future. The gifts of all are to be celebrated and when shared become a blessing to all.

Thank you to the Nominations Team for all their work this year. I appreciate the dedication and support of each member. A special thank you to Rev. Wanda Stride, who extended her term by a year so we would not be too short-handed. Wanda, you chaired the team from the beginning and your presence was helpful and integral to our work. We will miss you.

Covenant Support

Overseeing: Retirees Forum, Licensed Lay Worship Leaders Forum, Liaisons Forum

Hello everyone and God Bless. I am Bill Sheaves and I am the chair of the Covenant Support Team. Rev. Darren Liepold is our staff associate.

We have primary oversight of the pastoral relations processes as well as assisting in various time of conflict and difficulty in pastoral charges. We meet monthly except for the summer.

One of our main responsibilities is the consideration of every call and appointment in the Region. We review and recommend approval to the Assembly of Elders, who take our recommendations as further evidence of a suitable call for a particular Pastoral charge. In addition, we oversee the work of three forums: Licensed Lay Worship Leader forum (LLWL's), Retirees Forum and the Liaison Forum.

We interact with the LLWL's on both a formal level and informal level. We vote and recommend for appointment the candidates to be licensed. We also bring them together for mutual support and education events.

The Retirees Forum is primarily a body of collegiality and support for retired ministers who hold a vast knowledge and experience over decades together over the past year. It is the body that takes on the region's responsibility to care for and support a retired minister and retirees from other United Church work. With ZOOM ministers have been connecting to deepen the relationships across the region.

The Retirees Forum

The Retirees Forum is the leadership team for the Retirees Network (composed of all the retired United Church ministry personnel in the East Central Ontario Regional Council). We are part of the ECORC Covenant Support Team. There are about 160 of us. Our purpose is to provide opportunities for retired ministers to connect with each other for purposes of mutual support, discussion about theology, church issues, or any other topic of interest.

We have had monthly Zoom gatherings (open to all retirees) on topics including United Church Pensions, the new Regional structure, joys and challenges of our ministry experience, and sharing personal burdens. Our next session will be about "what we've learned in our experience that might be helpful to those in active ministry now". The number of participants has varied and usually we break into small groups for discussion.

We have a chat group on Facebook through which retirees can address topics which are of joy or concern to them. And we have a list of retired ministers who are available for pulpit supply etc. A list is available through Caroline Giesbrecht.

Our ministry retirees have a wealth of experience and knowledge (maybe even wisdom!) to share, so if anyone has ideas of how we might be helpful to the church and its communities, please let us know. We can be contacted directly or through Karen Wilson and the ECORC website. The leadership team for the Retirees Forum consists of Ian Robb, Elizabeth Macdonald, Wayne Hilliker, Judy MacGillivray, Ed Bentley, Robert Lepage, and Caroline Giesbrecht, as secretary.

The Liaison Forum

The Liaison Forum, chaired by Steve Coles, provides support and education to the Liaison persons who provide front line support to the pastoral charge during ministry change. The process outlined in Churchhub.ca is the basis for this ongoing work.

Although we continue to meet on ZOOM we are now able to meet in person with Communities of Faith that are having conflict. We hope that the CST can continue to have a deeper interaction, encompassing our Region's commitment to being and affirming and anti-racist Church.

All Calls and appointments are now recorded on Churchhub. The Pastoral charge approves a call or appointment (usually at a congregational meeting) but during the pandemic that can happen through the governing body. This decision is then written up on the appropriate form for calls or appointments on Churchhhub.

Once accepted this form is transmitted to the Minister, who has been selected on the form and based on their request through Churchhub, to be made available for search. The Minister then must agree and approve their Call.

When the two approvals have been received, this Call or request is then placed for evaluation before the CST and finally the Assembly of Elders where it is approved. The final approval is up to the Region.

Churchhub will publish via email the approved form of all those who have agreed to the Form. Once this confirmation is received, covenanting services can planned with the Liaison who has worked with the pastoral charge.

Licenced Lay Worship Leaders (LLWLs)

The year 2022 was a very productive year for the LLWLS in the East Central Ontario Region and 2023 is off to a busy start.

There are now 30 approved LLWLs in the Region with two more approved to be tentatively added by June. Twenty-five are presently available for pulpit supply in communities of faith other than their own home church.

There are six members on the LLWL forum (two clergy and four LLWLs), plus Karen Wilson as ECORC staff rep. A new revised rewritten LLWL policies and procedures manual was recently signed off by the Forum and now has been forwarded to Rev. Darren Liepold and the Covenant Support team for final approval. Thanks to Nancy Payne for authoring this re-write. There have also been some substantial additions to the Forum (and Network ECORC website over the last year with more upcoming. The last renewal for all LLWLs was January-May 2022 and scheduled again in two years (January-May 2024. Rev. Cathy Gradante is the Chair and Paul Kneebone is the Secretary. The LLWL forum met six times and plans for at least four times this year.

All LLWLs and individuals presently in the LLWL online course of study are all members of the LLWL network. Nancy Payne is the Chair and Paul Kneebone is the secretary. There were four online/zoom gatherings in 2022. There was a one in-person development gathering September 24th at Trinity-St. Andrews UC in Brighton with fourteen members and two clergy presents. Childrens story time during Sunday worship was the theme was organised by Rev. Cathy Gradante and Rev. Cheryl McMurray. It was also a great opportunity to socialize together and share a lovely lunch and conversation. The next LLWL Network in-person gathering was April 29th at Bridgenorth UC, again organized by the LLWL forum. Another in-person personal development gathering is planned for the fall of this year.

Thanks to Rev. Darren Liepold for his assistance with this team. We are committed to the well being of the Region.

Thanks also to Rev. Caroline Giesbrecht and Paul Kneebone for their assistance in this report.

Our Forums and Networks have done some innovative and exciting ministry over the past year, and I encourage you to take the time to read their reports that follow.

Anti-Racism Interfaith Intercultural Forum:

In the past year, our Forum has:

- (1) In partnership with the Indigenous Justice and Right Relations Forum, hosted an online event called Flames of Justice. During the event as part of our Portrait project, we presented portraits of Chancellor Murray Sinclair and Elder Murray Whetung to Carolyn Holmes chair of the Mark Street United Church council in Peterborough. Dr. Brian Carwana, Director of Encounter World Religions was the key-note speaker followed by Theological Reflection by the Rev. Alan Boyd.
- (2) Catered the reception for an anti-racism event held at the United Church in Brighton and was accessible also by ZOOM.
- (3) On November 8, 2022, we sponsored an event on reading the Bible from an anti-racism perspective by Dr. Dorcas Gordon, former director of the Toronto School of Theology and the TST Doctor of Ministry Programs.
- (4) Part of the Implementation plan is to move the Region's Anti-racism policy forward through qualitative education. As a result, we sponsored a weekly Interfaith World Religions Course with Dr. Brian Carwana from October 26, 2022 to November 23, 2022.
- (5) Planned the BLACK HISTORY MONTH for the Regional Council event held via ZOOM on February 22, 2023 with three panelists: Charmaine Mugambe, Heather Henry and David Daniels. It is hoped that from this discussion, our Forum might be able to partner with some if not all these panelists to dismantle anti-black racism.
- (6) **Met with THE REGION'S LIAISON COMMITTEE**. Acting Personnel Minister Darren Liepold was in attendance as well. Some discussion ensued around the following issues:
- (a) The approved Regional Council's Anti-Racism Policy and Implementation Plan. The question was asked as to why not all congregations in the Region are aware that there is an Anti-racism Policy, or, congregational leaders have not received a copy.
- (b) **Position descriptions** from the lens of Anti-racism, intercultural, interfaith what needs to be imbedded in the Position Descriptions of all Leaders? How do we inform, and include the vision and strategic plan of our Region, and Denomination?
- (c) **Advertising for Positions**: Does our advertising include the Diversity/Inclusivity clause which lets potential applicants know that we are an inclusive organization?
- (d) **Are congregations open to hiring a person from another cultural background** and if so, what will be done to prepare both the applicant and the congregation for such a journey?
- (e) **Racism in our Region**: Once again, the Liaisons were informed of researched evidence, with examples of recent racist events.
- (f) Training: Liaisons were reminded that our Regional Council will pay for lay leaders to take The United

Church of Canada's anti-racism training, and that as Liaisons they could be helpful in informing congregations of this training, or, suggesting that some particular person/persons take the training. (This training is currently being updated).

(g) Since the Liaisons are working with the **Ontario Human Rights Code**, the issue for us as Church and seeking to be Disciples is being well informed of the Theological underpinnings of the Ontario Human Rights Code. This is crucial. What Christian assumptions are we bringing to the Human Rights document?

(7) THE ANTI-RACISM FORUM'S SURVEY OF OUR REGION:

Results were shared with the Liaisons. Researched evidence shows that we have twenty-three different languages spoken amongst various members/adherents in our congregations. This highlights wider and deeper intercultural legacies in the East Central Regional Council. Regarding areas of support requested by Congregations in our Region there are written requests in the following categories:

- (1) Education, (2) Strategies for making connections with and interacting with our neighbours, (3) Training in various formats, (4) Resources general, (5) Resources for worship.
- (8) **SYMBOLS, SPACES AND HISTORY:** (Portrait project through the anti-racism. intercultural lens). Members of the FNJT Committee are being requested to assist in moving this forward in their particular congregations. One or two examples given here are: Trinity-St. Andrews United Church has hung a portrait of Chancellor Murray Sinclair. Mark Street United has done the same and is awaiting a portrait of Murray Whetung from his son.

Rev. Dr. Aruna Alexander has been invited to join the DEI Committee of the Hastings and Prince Edward District School Board. If our members hear of any school issues, they can contact Aruna.

Mission Through Property

The Mission through Property Team of the East Central Ontario Regional Council shall assist the East Central Ontario Regional Council meet its responsibilities as outlined in The Manual C.2. The Mission through Property Team shall exercise specific responsibilities to serve, support and provide oversight of the financial responsibilities of the East Central Ontario Regional Council and of the financial viability and

property matters of the Communities of Faith. Details of these responsibilities can be found on the ECORC website as the Property and Finance Policy.

This workbook of the East Central Ontario Regional Council outlines the details and motions related to the work of the Mission through Property team. These past few months have continued to be very busy times for our Team. As Community of Faiths (COF's) look for every possible way to generate funds to cover expenses whether that be utilizing reserves from historical sales of properties and manse funds, current sales of Property, manses and surplus lands, the Mission through Property team have worked with many COF's providing support as they wrestle with various options available to them. Churches will continue to have significant financial stresses on them and this along with declining, aging members and aging buildings are causing some COF's to consider other options like amalgamations, shared ministries, permanent closings, and possibly new ways to carry out their missions while others just give up and decide to disband.

Under the guidelines of the United Church of Canada that directs us to retain property assets and that we must first look at development projects with the help of Kindred Works before considering church properties for sale and even then properties be held by the Region in trust for future ministries of the United Church of Canada. We are currently working with 10 COF's who are engaged with Kindred Works to explore alternatives that they provide rather than just selling off assets to unknown developers and living from the investment income from these sales to continue and prolong their traditional way of doing Church. Four COF's have signed on to begin the development with Kindred Works being Dunbarton Fairport in Pickering, Trinity United in Uxbridge, St Stephens in Oshawa and Cedar Dale in Oshawa.

The Mission Through Property team has established an ECORC COF Assistance Fund to be administered by the Toronto United Church Council (TUCC) for the purpose of providing, from the investment proceeds, grants and various types of loans to COF's. Details of this fund and how to access it can be found the ECOR Website.

To assist COF's with the issues of ongoing property management during the timeframe when a property or asset has been declared surplus to need by the COF and is sold or taken on as a development project by Kindred Works the Mission Through Property Team developed a Property Management Agreement (PMA) with Toronto United Church Council (TUCC) assure that properties are adequately maintained, managed, insured, rented to community user groups when possible and eventually manage the sale of the property. This will lessen the stress on the COF during these emotional times and assure that the property is taken care of.

In April we held are first "Grants and Loans" information session where we learned about grant and loan opportunities with the various arms of support within the United Church. We also were introduced to the new Insurance structure at General Council which should reduce the insurance premiums. We also learned that there is a blanket coverage for all COF's Directors and Officers coverage provide by The United Church of Canada so individual COF's do not need to carry this themselves. Contact the United Church offices for details of these two insurance programs. Details of this information session will be available on our website.

The MTP Team introduced a program to receive and review annual reports of all COF's. We hope to get a better understanding of the strengths and weaknesses of the ministries ongoing in our COF's, the financial health and well being so we can look at ways we may help COF's before it is too late.

I hope that our COF's will start to see better times ahead. Just remember that the ECOR Mission Through Property Team is there to assist you in what ever way we can.

Prayer Shawl Ministry

Prayer Shawl Ministry – Report to East Central Ontario Regional Council Spring Meeting 2023 At its spring meeting, the East Central Ontario Regional Council provides shawls for new and retiring ministers and new staff. In 2022, 6 shawls were given as a reminder that God walks with people on new journeys. Prayer shawls were also given to ECORC Staff for use in pastoral care.

When possible, shawls are made by people who know the recipient; always they are blessed with prayers 'woven into each stitch.' In 2022, when we were not meeting in person, shawls were mailed. This year, presentation in person is planned. I am reminded of the saying: "The difficult we do right away; the impossible will take longer." Even the most fleet-fingered knitters may take up to 30 hours to create a shawl; knowing the retirees' names and estimated number of ordinands several months in advance makes it possible to create and collect shawls for the celebrations at the Spring ECORC Meeting. In spite of very good and much appreciated efforts, lead time was not possible this year. We continue in hope that shawls will be ready for the Spring Meeting and want all to know that the prayers will be there, even if shawls need to be mailed later.

Another aspect of the ECORC Prayer Shawl Ministry is assistance to prayer shawl ministries in our Communities of Faith. Some of these also provide Pocket Prayer Shawls, several inches square, often created with a cross in the pattern and given with a blessing card such as:

Intended to be held,
kept in a pocket or just nearby,
a Pocket Prayer Shawl holds the
thoughts and prayers of friends who care.
May the one who receives this "shawl"
be wrapped in God's love.

Moving forward through this time of transition to gathering in community, we proceed with hope for new and renewed collaboration and gratitude for opportunities to celebrate with those who give service to God's work.

The Annual Report of Old Hay Bay Church 1792



National Historic Site of Canada 2365 South Shore Road, Napanee, Ontario February 28, 2023

The church had another productive year. The devotion and stability of the Board of Trustees has been fundamental in getting projects done and the church being open for the summer months.

Our season started early with a spring wedding, followed by two more during the summer. Our July sunset service had a small, but appreciative attendance. In August our Annual

Pilgrimage service was held outside under the direction of Rev. Phil Hobbs and Rev. David Jones. Our guest speaker was Rev. Bill Smith, who spoke about the sacred grounds in and around the church. In September we were one of the stops for the Lennox & Addington Cycling tour. Although not a huge money maker it is a great opportunity to promote the meeting house to the approximately three hundred cyclists that pass by. Our custodians are great supporters and helpers at all events.

Although we were unable to secure contracts for any of the remaining restoration projects in the church, many things were accomplished. The search for contractors continues.

The cottage received: painted steps; new screens on all windows; new shelf in front porch for the storage of our Voices United Hymn books; new clothes line for custodian use; new taps in the bathroom; and repairs and replacement of parts in the well pump. Outside the cottage the picnic table was painted; trees were trimmed; thermometer on cottage; and the metal shed was repaired to having lockable doors. For around the grounds of the church we purchased a new picnic table and received a second picnic table as a donation from the Napanee Home Hardware. The picnic table has a metal label acknowledging their donation. Gate posts, with a removable rope, were installed on the eastern entrance to the property for better control of where vehicles enter the grounds. The cemetery received a major pruning to the apple trees, providing a much nicer looking cemetery for visitors to walk through.

The church continues to receive support from local media outlets for all its public events. We continue to use Facebook and our website www.oldhaybaychurch.ca for promotion and learning opportunities. The six large binders of research from the late Rev. Lamb were photographed for future use and distribution.

We had a replacement cost assessment of the church completed to provide us with the necessary documentation for a new insurance carrier. This allowed us to participate in the Ontario Historical Society

insurance program managed by Jones DesLauriers Insurance Management Inc. at more than a 30% savings from our previous carrier.

Our attendance was lower than pre-Covid numbers, but most custodians felt the visitors were more interested and stayed for longer visits. The reasons why they visit are varied. They seek information on the religious history and significance of the church, the search for family connections to subscribers, their connection to the drowning victims of 1819, preachers and families in the area, the unique architecture, and some as they are interested in 'churches ' . The most common comment is the peace and calm they experience inside the church.

On behalf of the Board of Trustees I wish to thank the United Church of Canada for its continued support of this historic site. I am often reminded of the wording of Richard Duke in his 1892 appeal to the Methodist Church of Canada, "Any visible thing that perpetuates the memory of a special providence is worth preserving. This old Hay Bay Church links us visibly with the rise of Methodism in Ontario; it is, so to speak, a visible embodiment of a hundred years of our history as a distinct people in this land." As a faith, we were a leader then, and we continue to be so today.

Bedford House



Thanks to ECORC's Doing Mission Together & M&S grants



Forty people gathered at the Peterborough Library to celebrate the volunteers, financial supporters, and participants that have created the Bridges community. The occasion was the 7th Annual Meeting of the Bedford House Community Ministry.

At one point, our facilitator invited Bridging Team alumni to form an inner circle facing the outer circle of supporters. The two circles were invited to pair up. Bridging Team alumni were asked to tell a story about how the Bridging Team experience had changed their lives. **Reverend Paul Reed, representing the United Church later wrote:**



"Gathered in the circle, we sang songs (hymns), shared a thanksgiving (open-eye prayer) shared food (broke bread together), and listened to several heartfelt testimonies about the life-changing experience (a "message of hope").

Regardless of the language used, it was clear to me that the participants with whom I spoke, were describing the circle and the friendships made through Bridges as where they found a spiritual home.

Bridges Peterborough, a project of Greenwood United Church and Bedford House Community Ministry, invites participants to explore the ever-widening gap between privilege and poverty in our communities.

We create safe spaces to share stories, laugh, ask good questions, and learn to listen well. Together, we explore the cultural divides that would normally keep us strangers to one another's worlds.

Ten "well-resourced" Mentors and five "under-resourced" Catalysts, led by trained facilitators, follow a process mapped out in the Bridging Team Facilitator's Manual. In carefully organized safe spaces, a weekly "Bridging Team" gathers - and the magic happens."

The Bridging Team model is based on the <u>lived experience</u> of <u>Lynn Smith-Reeve</u> as she invited a circle of mentors to support her own seven-year journey from poverty to commissioning as a Diaconal Minister. She now trains new Bridging Team facilitators to start their own Bridging Teams.

The United Church's support for this experiment has been critical. We've received support from all levels of the church. That "investment" in this new way of being faithful in a diverse cross-cultural gathering is ready to be shared.

Emerging in 2023: Our fourth team "Bridging Artists" invites fifteen "strangers" - including creative souls who live in precarious circumstances — into the process of forming a support network of friendships. Their journey started in March — **supported by the "Doing Mission Together"** grant in 2022.

The Bridging Stories experience will be led by Todd and Laura, two graduates of Bedford House's Facilitator training program. Both are also alumni of past Bridging Teams. Laura's laughter is contagious. The joy and wisdom she shares has been earned through decades of battling her way through abuse, addiction, and cancer. "This is the best thing that's ever happened to me," she explains as her motivation for creating a new team.

In the *Bridging Poverty and Privilege* webinar, participants from across Canada heard about the spiritual practices of *Hospitality, Dignity, and Curiosity* that are key to the magic experienced in Bridging Teams.

As a certified "Bridges Out of Poverty" trainer, Lynn highlighted the lessons learned through this educational framework – lessons that Bridging Teams use to create a common language and analysis.

Annual Report to Ucc Regional Councils
April 2023



Greetings and grace to you as you convene for your Regional Council meeting. May that time nourish and sustain you, as you build up the church and enjoy the goodness of *being* the church.

I am pleased to report that AST has experienced several interesting events and changes in the last year. Here are a few of them.

In the summer of 2022, and for the first time since 2019, we were able to have our summer MDiv students take their courses in person and occupy rooms at the campus residence. I had several opportunities to meet with students both as a group and individually. They were pleased to meet faculty and fellow students in person and to share worship, meals, and recreation with their colleagues.

As the Fall 2022 term began, our courses were offered remotely or in hybrid (both virtually and in-person) form. As none of our own students applied for residence, all our rooms were rented to international students from other institutions in the Halifax area. However, we maintain a policy of preferential availability for AST students. In the meantime, we are remaining true to the fundamental values and mission of AST by reaching out to those who would have to pay much more for accommodations or would be unable to study in Halifax because of a lack of rental spaces.

In other good news, the Province of Nova Scotia has provided AST with a grant of \$3M to renovate and upgrade our residence facilities, work that is long overdue. The funds will allow us to repair brickwork, install new plumbing, make wi-fi system updates, and upgrade shared kitchen and bathroom facilities.

At the May 2023 Convocation, the first cohort of students in the Diploma in Missional Leadership (DML), all of whom are affiliated with the United Church, will graduate from this new program. The next cohort of the DML will begin in early 2024. This learning opportunity will be available to persons from all denominational backgrounds as we build a new complement of ecumenical partners in mission. AST is currently in the last stages of the formal application processes to launch a Bachelor of Theology degree program. The key purpose of the Bachelor of Theology degree is to increase accessibility to higher education in theological subjects. Those who desire postsecondary education specifically in the theological disciplines but lack an undergraduate degree will benefit from this new degree. A direct-entry undergraduate degree option will assist them in their vocational and educational goals.

A key element of the Strategic Plan adopted by the AST Board in February 2022 is collaboration with Saint Mary's University (Halifax) as part of the now twenty-year old Memorandum of Understanding between our two independent institutions. In the past year, we have integrated our student information infrastructure into the Banner system at SMU. That project, funded by the Nova Scotia government through the NS Council of University Presidents, is almost complete. The initiative has provided significant benefits to our students, faculty, and staff. It has allowed AST to move from paper-based to IT-based processes for handling many things, from course registration to student records and course changes.

We will see some significant leadership changes at AST over the next several months. The Presidential Search Committee (even as this is being written) is nearing the end of its work to find a candidate to propose to the Board as AST's new President. As well, a second search committee is in the process of seeking a new Academic Dean to succeed Rev. Dr. Rob Fennell who has served in that role since 2017. His outstanding contributions to the university have earned him a well-deserved sabbatical which will begin this summer. Finally, Rev. Dr. Linda Yates succeeds Dr. Peter Secord as Chair of AST's Board of Governors.

We would like to express deep gratitude to our partners in The United Church of Canada—the General Council, the Regional Councils, the Board of Governors of Pine Hill Divinity Hall, and the local churches, leaders, and ministers—who support AST's work in a variety of ways. Financial support from the General Council and Pine Hill Divinity Hall are critical to our capacity to function as a university focused on theological education for ordered ministry candidates and lay leaders. The local churches support AST through discernment processes for potential ministry candidates, by encouraging lay people to continue their lifelong faith learning, by calling and supervising our graduates who serve your congregations, and by your vital and deeply valued financial support. If your Community of Faith has not yet made a gift to AST this year, I ask you to consider doing so in the next month or two.

AST continues to seek to be responsive to the emerging needs of the church and society as we serve together in God's world. In this, we are grateful to be your partners.

Centre for Christian Studies – 2022

A Year of Anticipation and Adjustment

2022 for The Centre for Christian Studies was a year full of preparation, anticipation, and adjustment. It began with the departure of David Lappano (former program staff) and Michelle Owens (former principal). It set the stage for two search teams to look for new staff. Meanwhile, Ken Delisle served as the interim principal for most of the year until the arrival of the new principal. Through several months of internal preparation, discussion, and searching, CCS now has new Program Staff Alcris Limongi and Alan Lai; the new principal. They both started in the month of October.

Alcris Limongi came to CCS from Parkdale United Church in Ottawa, where she served as the Minister of Pastoral Care. Alan came from Vancouver, where he was the minister serving South Arm United Church in Richmond. Alcris originally came from Venezuela, and Alan, Hong Kong. Together, they bring intercultural perspectives and years of leading anti-racism and intercultural learning to the CCS community. Covenanting service for Alcris and Alan were conducted on November 23rd, at Westworth United Church in Winnipeg.

With the assemble of the new team complete, the staff spent the last few months of the year building new relationships and sharing ideas and practices. The spirit of exploration and relationship building was high. With Alan's photographic and video production skills, CCS has begun to post more updates and videos on the school's Facebook page and YouTube channel.

While the searches were going on most of the year, CCS's programs and operation continued smoothly with dedicated staff and volunteers. CCS continues to offer courses online and in-person, which included: Power and Privilege, Ages and Stages, Ministry as Community-building, Health, Pain, & Trauma. CCS Fridays is a series of free, one-hour online workshops and discussions offered mostly once a month to connect friends and the wider community. On April 3rd, during the Annual Service of Celebration, Aileen Urquhart was awarded the Companion of the Centre Award.

Financially, CCS continues to rely on the commitment of the denomination and generous donors who believe in the mission of the school. Lori Stewart, our Development Coordinator, has done a fantastic job connecting with donors and applying for grants and funding. While denomination funding is decreasing, and Endowment portfolio is not as promising as before, we are committed to working towards financial sustainability. We are thankful that many of our donors remain committed to diaconal education and bless us with extraordinary generosity in 2022. CCS is anticipating major Endowment fundraising campaign in the coming years.

There is no doubt the pandemic has challenged the school on many fronts, including programming, student enrolment, marketing, and so on. It disrupted more than just in-person gathering, but also concepts of theological education, teaching, learning, and service in the world. However, the process of rebuilding has begun.

Additionally, we continue to enjoy hosting the **Designated Lay Ministry** programme at the College, while we await further word from General Council about its future.

There's so much happening at our College right now, but we wouldn't want to miss talking about the **Lifelong Learning Pathway** we've been developing. It has been researched and developed over the past two years, and we're currently testing it with a pilot project of eager learners. This new programme opens the great privilege of theological and spiritual reflection to a wider community of learners beyond our traditional degree programmes. Whether you're exploring Christian discipleship through leadership in your faith community or in the wider society, or seeking paths of wisdom in other spiritual traditions, our certificate programmes (*Leadership in the Faith Community, Leadership in the World*, and *Spiritual Exploration*) create new possibilities of study.

Our new Lifelong Learning Pathway prioritises your own learning goals and pairs you with your own educational guide. We'll help you identify educational resources and opportunities, develop a personalised learning plan, and build a portfolio of reflective work. You will progress at your own pace toward the competencies described in your chosen certificate. This unique new programme is perfect for seasoned pastors seeking continuing education, lay leaders who want to engage in theological work to enhance their ministries and vocations, and the spiritually curious wisdom-seekers who will benefit from a flexible and supportive framework of reflection. Regardless of your previous formal education, St. Andrew's Lifelong Learning Pathway opens up a treasure-trove of theological and spiritual exploration to anyone who desires it!

As you can see, we're at a very exciting place in our history. The challenges of the past few years have unleashed our imaginations and propelled us into God's future. The United Church Studies Program at Montreal Diocesan Theological College Report to the East Central Ontario Regional Council February 2023



Forming a new ecumenical college

The amalgamation of The United Theological College (UTC) and Montreal Diocesan Theological College (Dio) in 2022 is the culmination of five years of planning and collaboration. The process has called for courage and risk, letting go of the past,

vision, prayer and discernment, and a deep commitment to ecumenical collaboration.

In September 2022, Montreal Dio amended its constitution to provide for United Church participation in its governance and agreed to ensure the continuity of United Church theological education in Montreal, under the working name of *United Church Studies at Dio*. It is now required that one-third of the Dio Board be members of the United Church of Canada. The position of Director of United Church Studies was created to support ministry formation in a United Church tradition and ensures that United Church-affiliated students meet requirements for United Church Testamur. Montreal Dio is now an *ecumenical* institution forming students for ministry in the Anglican, United Church, and other traditions, in partnership with the Montreal School of Theology and McGill University.

We are encouraged by the continued growth and increasing diversity of our student body. Over half the United Church-affiliated students are francophone or fluently bilingual, most were born outside North America, and over 85% of them are newcomers to the United Church and to Canada. Outside of our regular degree programs we offer courses for Admission Minsters and a week-long residential orientation program for leaders new to the United Church. These programs are intercultural in nature, opening us up to conversations and relationships that nurture our growth as an institution with regards to justice and spirituality. This rich diversity of language, culture, and tradition is changing us and the church – informing how we teach and learn, how we converse across differences, including theologically, and how we experience God's spirit in our midst.

Courses and Events for Lifelong Learning and Ministry

The amalgamation of UTC and Dio has enabled us to expand our offerings and extend the reach of our programs for lay people and ministry personnel. We are focusing on programs that support a renewed and vibrant church and that help people grow in faith and in leadership.

Open Enrolment Courses Winter 2022 to Spring 2023

These online courses are offered for four to six weeks. Often, groups from congregations take the course together. We offered 9 courses this year on various topics related to the Bible, spiritual formation, and Christian leadership and attracted over 120 participants from across the country.

What Next for the Church: Congregational Ministry in a Pandemic Shaped World

Conflict Resolution Jesus Style

February 9, 2023. Day-long in-person event with The Rev. Susan Brasier, J.D., and The Rev. Dr. Karen Petersen Finch.

Formation for French and Bilingual Ministry

One of our key areas of focus this year has been equipping the church to minister in the unique context of Quebec and strengthening French ministries across the United Church. This includes a partnership agreement with *La Table des ministères en français* of the United Church which helps us to support ministry formation for francophones. We have also expanded our program for bilingual ministry by hiring a dedicated program director to oversee French formation for students and implement the revised *Certificate in Bilingual Ministry* program. In May of 2023, we will be offering a week-long *French for Ministry* intensive course designed to strengthen the linguistic competence and cultural know-how of those working in French or bilingual ministry and pastoral contexts.

Montreal Mission Internship

In summer 2022, Dio launched the Montreal Mission Internship, a 9-week program for 18- to 25-year-olds that combines social service work with theological reflection and intentional community. Last summer, thirteen young adults from across the country came to Dio to put their faith into action and explore a call to Christian ministry beyond the walls of the church. Applications are now open for the 2023 program, which has been expanded to host 18 participants.

United Church Orientation Learning Circle May 2022 and May 2023

A week-long residential event was held in Montreal from May 30 to June 3, 2022 for United Church Admission Ministers to learn the historical and theological context of the United Church, the core values, structures, policies, and vision; and to help the church live out its commitment to anti-racism and intercultural community. This event will be offered again in May 2023 to an expanded cohort of leaders, lay people, and ministers who are new to the United Church.

Plans for 2023

In addition to our regular programming and courses, Dio will begin to develop a long-term plan for its future as a renewed ecumenical institution. In the face of challenges and transitions within and beyond church walls, the college will seek to discern its role and the ways it will continue to form leaders for a vibrant future church.

Emmanuel College

The current faculty is keen to go out into different communities of faith, promote Emmanuel and share their scholarship and wisdom. Andrew Aitchison as Admissions Counsellor and Recruitment Coordinator will be a liaison connecting faculty with communities. Please let him know if your communities want to invite our Christian, Muslim or Buddhist faculty. That would be so wonderful.

Back in Person: Buzzing with Joy and in Gratitude

Emmanuel College was back in person after two long and challenging pandemic years online. We had a heart-warming in person orientation with close to 100 new and "returning" students who had never been to the college. We held a special fall graduation celebration for those who convocated online in 2020 and 2021.

Spiritual and religious practices on Wednesday are alive and well and were offered Monday through Thursday with the leadership of Spiritual and Community Life Coordinator, Beth Ann Fisher, through the leadership of our first ever Interfaith student Spiritual Life team who is taking a year-long course "worship and ritual leadership practicum" with instructor, the. Rev. Dr. David Kim-Cragg.

Hybrid Master of Divinity Program

Building on our experience of remote delivery throughout the pandemic, our Master of Divinity program has been approved by the University of Toronto to be offered in a hybrid mode of delivery. This means that up to two thirds of the degree can be done online. We are excited as we hope this will reach more prospective students outside of the Greater Toronto Area.

All Members of EM Re-Connected and Networking

One of my priorities as principal is to re-connect all members of the College as we emerge from many years apart. We are anticipating many wonderful anniversary celebrations and reunions with the UCC's 100^{th} anniversary in 2025 and EM's 100^{th} anniversary in 2028, so keep an eye out for our various events to celebrate these historical milestones.

Another goal I am focusing on as principal is the land on which we are located. Concurring with Victoria University's strategic framework on sustainability, and commitment to right relations with Indigenous communities which is laid out in the EM strategic plan, I am seeking to create a garden with the participation of the Indigenous community and to remove the lawn grass from our courtyards. This idea has generating some excitement and we received a starting grant from the United Church Foundation's Seeds of Hope to get us started! So please stay tuned and feel free to share your ideas and spread the news. it is my hope that the courtyard where the crucified woman statue is standing will be dug up next spring!

Financial Support

Emmanuel College continues to provide significant financial support to students. Through the John W. Billes Fund, Emmanuel continues to provide 100% of tuition coverage to all domestic students who are registered full-time in the M.Div. program and who are engaged in The United Church of Canada's candidacy pathway process. I just want to say THANK YOU all for your continued support to Deaf ministry with grants and your personal support. God bless you all!




Rev. Dr. John Young

Rev. Paul Packman



and many other experiences.




Rev. Irvin Johnston

His parents James Small and Lola Small (nee Kyles) and further back, had lived in the area since the 1800's. The family roots

Bruce spent his childhood in Grand Valley. His father was the village butcher. His mother Lola, at one point, qualified as a teacher after riding the bus back and forth to Toronto. graduated from the Orangeville High School and completed his Bachelor of Arts in History from what is now known as Wilfred Laurier University in Kitchener. Bruce followed his convictions – he referred to it as "a calling" with Masters of Divinity from Emmanuel College at the University of Toronto.

If you asked anyone and there would be thousands of people who were touched by Bruce over his life, what his greatest qualities were, a sense of humor would be tops. The lives he touched on a daily basis, on Sunday morning's, through all of life's milestones, from birth through confirmation, adulthood, parenthood, retirement and death, all benefited in some way from meeting and knowing Bruce and the spiritual care he shared.

Bruce personified the values of diversity, inclusion, respect and justice. He was a social justice advocate at heart, taking on and championing the issues of the day, be they and not limited to gender equality, human rights, the environment or homelessness. The United Church could do no wrong in Bruce's mind. The family dinner time was always dominated by questions about human rights, respect, equality and fairness. Bruce was a spiritual and humanitarian care-giver. He made his mark on the world around him and the world is better for it. Of all of his famous one-liners, perhaps the sincerest was, "remember who you are".

Bruce was ordained in 1961. He served congregations in Bristol (Montreal-Ottawa) 1961-1964, Stirling (Bay of Quinte) 1965-1971, Park Street (London) 1971-1979, Robinson Memorial (London) 1979-1987, Grantham (Hamilton) 1987-1996, and in retirement Grace (Hamilton Conference)


Rev. David Timpson

The Rules of Debate and Order

1. Presiding Officer

The function of the Presiding Officer is to preside, with all that that implies. The Presiding Officer should not attempt to control the decision of the Court, but may express opinions on any matter before the Court. If the Presiding Officer wishes to introduce a motion or to present a report, the Presiding Officer shall ask another member to preside, and while out of the Chair shall be an ordinary member of the Court and must not assume the chair until the matter is disposed of. The Presiding Officer does not vote except in the event of a tie.

2. Questions of Privilege and Order

- (a) A point of order may be raised while a matter is pending or while another member has the floor. When a point of order is raised it must be dealt with by the Presiding Officer without debate. If a member has the floor when a point of order is raised by another member, that member must yield the floor until the Presiding Officer has made a ruling.
- **(b)** Any member of the Court may appeal from a ruling of the Chair, but only at the time when the ruling is made. But where a ruling is a precedent the general question of its correctness may be brought up later when there is no business pending, but cannot then affect the business transacted under the ruling.
- (c) When an appeal from a ruling is made, the Presiding Officer should state the point at issue, and may give reasons for the ruling. The Secretary shall then put the question in the following form: "Is the ruling of the Moderator (or such other title by which the Presiding Officer is known) sustained?" If the vote is a tie, the Presiding Officer is sustained. The Secretary shall declare the result.

3. Orders of the Day

- (a) When an agenda has been adopted that does not specify the time for its items, such items are considered without time limit, unless the Court decides otherwise by a two-thirds (2/3) majority of those voting.
- **(b)** When an agenda has been adopted that specifies the time for particular items, such time shall be strictly adhered to, unless the Court decides otherwise by a two-thirds (2/3) majority of those voting. (2010)

4. Order of Priority on Motions

- (a) To close (2010)
- (b) To fix the time to adjourn.
- (c) To adjourn.
- (d) To take an immediate vote (two-thirds (2/3) vote required).
- (e) To limit or extend limits of debate (two-thirds (2/3) vote required).
- **(f)** To postpone definitely.
- (g) To commit or refer.

- (h) To amend.
- (i) To postpone indefinitely.
- (j) To deal with main motions.

5. Procedures on Motion

- (a) A member of the Court proposes a motion.
- (b) It is seconded. If there is no seconder, the motion fails.
- **(c)** When the motion is duly moved and seconded, the Presiding Officer states the motion and declares it open for discussion. If the mover has not already done so, the mover has the right to introduce the discussion.
- **(d)** A motion is out of order when it conflicts with a resolution previously passed at the same session unless it is a motion to reconsider.
- **(e)** Without the permission of the Court, no member may speak more than once on any motion or on any amendment thereto.
- **(f)** The mover of a motion has the right of reply before any vote is taken thereon or on any amendment thereto. Even when the Court has directed that an immediate vote be taken on a motion, the mover still has the right of reply.
- (g) When a motion has two (2) or more clearly defined parts or points of issue, and any two (2) members request that it be divided, a separate vote must be taken on each part.
- (h) Any motion may be withdrawn but only with the consent of its mover and seconder.
- (i) After a motion is under consideration a question of order cannot be raised against it unless the motion is ultra vires.

6. Procedure on Amendments

- (a) Any member except the mover or the seconder of the motion may move a relevant amendment thereto.
- (b) An amendment must be seconded, and if there is no seconder it fails.
- (c) A motion is amended by striking out certain words or clauses, adding certain words or clauses, or striking out all after the word "Resolved" (or the word "that"), and inserting another motion that will dispose of the matter. An amendment that merely negatives a motion before the Court is out of order.
- (d) There may be an amendment to the amendment, provided it has been duly seconded.
- (e) There is no limit to the number of amendments, but at any one time there can be before the Court only the motion, the amendment, and the amendment to the amendment.
- (f) When an amendment is disposed of, other relevant amendments may be proposed.
- (g) The discussion is always on the immediately pending question, and it must be voted on first. When a motion, an amendment, and an amendment to the amendment are before the Court, the two first named are "pending questions" and the last is the "immediately pending question." When the immediately pending question is disposed of, the one above it then becomes the immediately pending question, until the whole matter is disposed of.

- (h) When an amendment carries, it is not thereby adopted as the finding of the Court, but only changes the proposition under discussion.
- (i) When a motion, an amendment, and an amendment to the amendment are before a Court, three (3) separate votes including "for" and "against" must be taken. The first determines whether the amendment shall be amended, the second determines whether the motion shall be amended, and the third determines whether the motion, in whatever form it is then before the Court, shall be adopted or rejected.

7. Procedure on Voting

- (a) A vote is generally taken viva voce or by a show of hands. The Presiding Officer may ask for a standing vote. Upon motion duly passed, the vote shall be taken by ballot. In all actions of Church Courts regarding membership in the Order of Ministry requiring voting procedure, the vote shall be taken by ballot unless waived by unanimous consent; that is, on motion to waive, no dissenting vote is cast. See also sections C.5.7 and D.4.4 of the bylaws.
- (b) In the event of a tie, the Presiding Officer shall cast the deciding vote.
- **(c)** An affirmative vote on a motion does not validate any motion that is ultra vires of the Court, or that contravenes a decision of a higher Court.
- (d) In the conduct of United Church business, voting by proxy or by mail-in ballot is not permitted. Voting by telephone or by email is permitted only when it occurs during a meeting that is held in a manner that allows all of the persons participating to communicate with one another simultaneously and instantaneously. (2010)

8. Procedure on Motion to Reconsider

- (a) A motion to reconsider may be made at any time when the floor is vacant; but the actual reconsideration has only the same priority as the motion to be reconsidered.
- **(b)** A motion to reconsider must be moved by a member who voted with the majority. Any member may second.
- (c) If a motion to reconsider is dealt with at the same meeting in which the original motion was adopted, it will fail unless two-thirds (2/3) of those voting are in favour thereof. If a motion to reconsider is dealt with at a subsequent meeting of the Court, a majority of those voting determines the question.
- (d) When any motion to reconsider has been duly seconded, all action on the original motion is suspended until the motion to reconsider has been disposed of. No motion to reconsider can be entertained by the Court where action has already been taken under the original motion.
- **(e)** A motion cannot be reconsidered twice unless materially changed on the first reconsideration. If a motion to reconsider has been lost, it cannot be repeated.
- **(f)** A motion to reconsider is debatable only when the motion to be reconsidered is debatable. It cannot be amended, postponed indefinitely, or committed.

9. Motion to Refer

A motion to refer is debatable, but only as to the wisdom and manner of the proposed referral. It requires only a majority of those voting.

10. Motion to Postpone Indefinitely

A motion to postpone indefinitely, when in order, must be put without debate. If the motion is lost, it cannot be repeated or reconsidered. If CARRIED, the motion along with all amendments is removed from debate. At any time, it may be brought back before the Court by motion duly seconded and CARRIED. In such case the question is before the Court in exactly the position it held at the time it was removed from debate. A motion to postpone indefinitely can have no conditions attached to it. If a time is specified, it immediately ceases to be a motion to postpone indefinitely and becomes a motion to postpone definitely and is debatable. (2007)

11. Motion to Take an Immediate Vote

If a motion to take an immediate vote (for which a two-thirds (2/3) vote is required) is CARRIED, the vote shall be taken immediately. The mover of the main motion, however, shall have the right to reply before the vote is taken. If such a motion fails, debate on the main motion shall continue. A motion to take an immediate vote is not debatable.

12. Motion to Adjourn

A motion to adjourn is intended to suspend a meeting until another time. A motion to adjourn is in order only if there is already an agreed-upon time and place for resuming the meeting, or if the motion specifies a time and place for resuming the meeting. A motion to adjourn requires a seconder. Only the conditions attached to the motion to adjourn, such as time and place for resuming the meeting, are debatable; the wisdom of adjourning is not debatable. (2010)

13. Closing a Meeting (2010)

- (a) A motion to close is intended to terminate a meeting. A new meeting may commence, at a future time, by previous agreement or by call. There can be no conditions attached to a motion to close. A motion to close requires a seconder. A motion to close is not debatable. (2010)
- **(b)** When all the business and purposes of a meeting have been attended to and the Presiding Officer is satisfied that there is no further business before the Court, the Presiding Officer may declare that the meeting is closed, without the need for a motion to close. **(2010)**

14. Committee of the Whole

(a) Any Court, for greater freedom of discussion, may, on motion duly made, seconded, and CARRIED, move into a Committee of the Whole. Any such motion is neither debatable nor amendable, except only as to the scope of the subject to be discussed. The motion is

not in order if there is a pending motion to adjourn the meeting or to postpone discussion on the subject. (2007)

- **(b)** The first act of the Committee of the Whole is to appoint a chairperson and a secretary. A separate minute of the proceedings is taken. (2007)
- (c) The ordinary limitations of debate do not prevail in the Committee of the Whole. The chairperson restates the matter(s) to be considered. Discussion is then opened and is conducted informally. Motions need not be seconded. Unless the resolution creating the Committee of the Whole imposes restrictions, there are no restrictions, within reason, on the number of times a member may speak or on the length of speeches, except that priority is given to a member who has not yet spoken. (2007)
- (d) When the deliberations of the Committee of the Whole are concluded, the Committee will dispose of a motion that the Committee rise and report; this motion does not require seconding and is neither debatable nor amendable. When this motion is passed, a report is prepared and submitted to the chairperson of the main meeting, who reconvenes the main meeting. (2007)
- **(e)** A Committee of the Whole can neither adjourn nor terminate; it only can report back to the main meeting. It can, of course, recess briefly to prepare its report. (2007)

15. General

- **(a)** When a member utters language that another member considers offensive, the latter may require that the words be taken down. The speaker is then allowed to proceed. When the speaker yields the floor, the words complained of may be considered and dealt with. Such words may not be privileged.
- **(b)** Members of any Court should at all times therein conduct themselves with dignity, fairness, and understanding. The prime concern should be the good order and welfare of the church.
- **(c)** In any point not covered in The Manual, the parliamentary rules accepted in Canada (Bourinot) shall be followed.

Enabling Motions

1. Regional Council Roll:

That the Ministerial Roll of the Regional Council and the non-Ministerial Roll of the Regional Council thus constituted be now taken as read.

2. Other Delegates:

That anyone who has a role to play at the General Meeting of the East Central Ontario Regional Council (e.g. members of the Regional Council Assembly of Elders, Chairs of Leadership Teams and who has not been appointed as a delegate by her/his Community of Faith, be a full delegate with all the privileges of other delegates, and that the youth and young adult representatives from each Community of Faith be full delegates.

3. <u>Corresponding Members</u>:

That the students serving this Regional Council; the candidates for Ordination, Commissioning and re-Admission, those present as invited guests of this Regional Council, staff, resource persons, all who have registered for the Youth and Young Adult Event and other guests recognized by this court, be invited to sit as corresponding members of the Court.

4. <u>Minimum Number of Members at Meetings</u>:

That the minimum number of members for any session of this Regional Council is present (C.4.3, The Manual 2019).

5. Agenda:

That the agenda as printed and circulated, the reports, and the daily Agenda, be adopted as the Agenda for this meeting, subject to such changes as may be approved by this Court.

6. <u>Procedures for Reports</u>:

That the following procedure with respect to reports being presented at the Regional Council be adopted.

- a. Reports and any attendant recommendations be dealt with in the allotted time.
- b. If action has not been completed in the allotted time, then the Regional Council may:
 - i. Request that additional time on the Agenda be arranged by the Business Leadership Team
 - ii. Refer the report with its recommendation(s) to the appropriate body or bodies concerned, along with power to issue
 - iii. Refer the report with its recommendation(s) to the Assembly of Elders of the Regional Council for such action as the Assembly of Elders deems appropriate.

7. Meeting of the Assembly of Elders:

That the Assembly of Elders (which is empowered to act on behalf of the Regional Council between the meetings of the Court) be empowered to meet, if necessary, during the sessions of this Regional Council meeting and report those matters which require the approval of this Court.

8. <u>Inclusive Language</u>:

It is recommended that every attempt be made to use inclusive language in all worship, reports, petitions and discussions in this Court.

9. Business Leadership Team:

That the Business Leadership Team be members from the Facilitation Team

10. Scrutineers/Stewards:

That the Scrutineers/Stewards be members of the tech team.

Purpose: The purpose of this policy is to clarify limits of the budget process. The Manual C.2.5.				

Preamble

This document outlines the East Central Ontario Regional Council's policy and best practices regarding requests for funding outside of the approved annual budget at the annual meeting.

Policy

It is the policy of East Central Ontario Regional Council to affirm and uphold the use and function of the Business Committee for matters coming to the floor of the Annual Meeting of the Regional Council.

It is the policy of East Central Ontario Regional Council that any motion committing the East Central Ontario Regional Council to the expenditure of non-budgeted sums of money be required to have a budget attached;

It is the policy of East Central Ontario Regional Council that any motion committing the East Central Ontario Regional Council to non-budgeted expenditures which are presented during the Annual Meeting be automatically referred to the Assembly of Elders who may request input from the Mission through Property Leadership Team first before making the decision;

It is the policy of East Central Ontario Regional Council that in the interests of fairness and justice, requests for funding of projects or groups not covered in the existing financial budgets be subject to conditions and criteria similar to those that are currently expected of requests for Mission Support, and other funds available within the Regional Council.
