- 2) This month's Covenant Support Team was Darlene Hallett's last month as member of CST, and she was the LLWL representation on CST. Paul mentioned that he has submitted his interest in being a CST member through the ECORC online process (Nominations committee). Should know at Spring meeting who will be new CST member(s), going forward.

New Business:

The present guideline is that it such training is only intended for "remote rural" settings, so the majority of our Region does not meet these criteria.
