Land Acknowledgement & Opening Devotions – Rev. Kevin Fitzpatrick led opening worship by lighting a candle ('circle of friends' he received as ordination gift) and opened with prayer, reflecting on the flame and its analogy to many facets of our lives. Kevin recognizing that the Regional Council is part of an affirming ministry, and holds up each who are called to it, through integrity and encouragement. Kevin also recognized that we gather on the lands and waters of First Nations peoples, lands which remain unceded. Kevin called all to work towards right relations and towards truth and reconciliation.

Kevin shared the following scripture: Act 2:1-4 (Inclusive Bible) which is the story of Pentecost. This was followed by a guided mediation, reflecting on the gifts of the Spirit: wisdom, understanding, counsel, fortitude, knowledge, piety and fear of the Lord. Kevin invited all to be moved in/by the Spirit and share their gifts.

Welcome to Members; explanation of how the Assembly of Elders works; representatives/observers to Leadership Teams; choosing a Speaker – Paul Reed reiterated what was shared in his invitation to new members on the Assembly of Elders (extract here below):

Welcome to this year's Assembly of Elders. I extend this welcome to those who are new this year and to those in continuing terms. Together we are a new body.

The Inaugural meeting of the East Central Ontario Regional Council accepted a bold shift from traditional business governance structure and sought to reclaim our biblical language. You have been chosen through the discerning practices of the Nominating Team to be an Elder of the Regional Council. Members of the Assembly of Elders have a dual role of serving on behalf of the Regional Council and serving to the Regional Council.

Firstly, we assemble, not to represent the interests of the Leadership Teams, but to be a representative body to which the Leadership Teams report between full meetings of the Regional Council. The Assembly of Elders on behalf of the whole, receives and approve the proposed actions of the Teams. The Assembly of Elders evaluates the readiness of the recommendations regarding the policy and practices of the Regional Council with a view to a fuller picture. When required the Assembly of Elders makes decisions when policy and precedent do not offer a guide.

Secondly, a distinct characteristic of the ECORC Assembly of Elders, is that it is a body of equals. Each member may be expected from time to time to be the face and presence of the Regional Council. You could be asked to represent the Regional Council at special events or memorials. You will be expected to provide leadership and guidance to the Regional Council communities of faith and their representatives.

To facilitate the work of the Assembly of Elders, at the first gathering following the Regional Council Spring Meeting, a speaker is appointed. The Speaker, perhaps likened to the Speaker of the House of Parliament, has the role of guiding the meeting in an impartial fashion. The Speaker, with the Executive Minister prepares the agenda and guides the Assembly of Elders through the work in an orderly fashion. The Speaker is the presiding officer and guides the fall and spring meeting of the Regional Council.

It should be noted that the East Central Ontario Regional Council governance structure the Chair of Teams are not required or expected to attend the Assembly of Elders meetings. The Assembly of Elders receives written reports and recommended actions. To aid in communication and understanding, Members of the Assembly of Elders are appointed as observers to the various Teams and become the bi-directional conduit of information between Team and Assembly of Elders.

Minutes of the Covenant Support Meeting May 23, 2023

Darren led in prayer. New members Paul Kneebone, Rady Scott and Phil Hobbs were introduced to the committee. Addition of items to agenda was agreed to by consensus Approval of the Agenda was done by consensus Approval of the Minutes from the April 24th, 2023 was agreed to by consensus. Business arising from the minutes- none noted

Forum Reports

Liaisons: Steve Coles reported on behalf the Liaisons. Simcoe Street is thinking of closing their building and may begin worshipping as a separate congregation at Kingsview.

Licensed Lay Worship Leaders: Cheryl McMurry had a written report attached.

Retirees- Caroline reported that the last lunch and learn session was held May 3rd and that these would resume in the fall.

Mission Through Property- Ted said that the committee would be meeting tomorrow and would have a report for the Assembly of Elders. Some items of note. 6 groups have requested \$20,000 from the Mission Together Grants while only \$15,000 is available. So some tough decisions will have to be made.

Kingsview United in Oshawa needs significant roof repairs of over \$50,000. They will need our permission to spent this much money as per region policy.
