Assembly of Elders Accountability Report

Greetings in the name of the Risen One!

Join me in singing gratitude and hope as we raise our hallelujahs in Christ's name: the tomb is empty, and new life is our promise in Christ. I hope to hear your singing as we gather in Lindsay on April 19 and 20!

It seems unnecessary to begin this report with a reminder that we have just lived through a year of immense change, deep growing and learning to understand new policies, new staff, new pastoral charge arrangements... but here I am mentioning it anyway, because change has been such a prominent character in our interactions since restructuring in 2019!

As a musician, I can see that change has powerful potential. When I play music with other musicians, we agree to a certain framework within which we can experiment, express ourselves and delight in beautiful harmony. Sometimes that music is even enjoyable to people who are listening! But when someone introduces change, we have to be careful. If we know each other well enough, and trust each other as musicians, we can hold back and listen while the new structure emerges and jump in when we are confident of our place. Those scenarios are ideal and transformative, and the new music becomes much more than just one person's vision — it becomes a spirit-filled exploration of possibilities that draws out courage and excellence in even the most timid among us! Sadly, most of us musicians are mere mortals, and we rely on that framework. If change is to happen, we need it laid out for us ahead of time so we can think about it, and if trust is extended tentatively, we have to understand the beginning and middle and end before we even consider putting bow to string or fingers to the keyboard.

It's hard to build that kind of trust in a committee, when membership shifts each year. It's even harder to do that amongst 200-odd communities of faith who are also busy singing their own songs that must adapt to a whole different set of musicians. But that is our work! Because the song does not belong to us. We sing the melodies inspired by Christ's spirit who calls us to be deeply faithful and bold, but because we are mere mortals, we must do that by laying out the framework, and building trust one note at a time.

So let me tell you about the work of the assembly of elders, and how we are hoping to build a trusting community, while balancing the constant change and pressure of the world around us.

This year the assembly of elders elected a new speaker from among its members (the one writing this report, Rev. Wanda Stride). I have come to this role from another role, that of lead commissioner for General Council 44. Normally those two roles would be separate people, and going forward, we welcome new leaders as we grow into a greater understanding of the work of the assembly of elders. We are continuing the song that began in 2019, the one that Rev. Paul Reed conducted through the online years of Covid 19.

We welcomed our new Executive Minister, the Reverend Éric Hébert-Daly who left his role responsible for French Ministries in the General Council Office to guide our three regional councils through strategic planning, in addition to supporting the important work carried out by the ECORC teams. Under Éric's leadership we are shifting in how we spend our time during monthly meetings.

Our framework doesn't include a lot of literal singing! The Assembly of Elders receives recommendations from the various teams about important work happening. We give final approval to appointments and calls, building sales, amalgamations and so on. We hear about pastoral relations concerns and help discern ways forward. We hear about celebrations and rejoice with pastoral charges as they flourish. We sing our hallelujahs with all of you.

We also lament when we hear of faithful mission embodying the brokenness of this world, as was the case in Belleville this past winter. Bridge Street United's partnership with John Howard Society, offered a daily luncheon for the city's most vulnerable, but like many other communities across North America, fell victim to poison-infused substance and the city declared a state of emergency as up to 17 people were taken to hospital.

We lament the closing of seven Churches within the boundaries of our regional council, some who have decided to share ministry with neighbouring communities of faith, others who can no longer maintain their buildings.

Twenty-three people in our midst joined a pilgrimage to global partner Emmanuel Baptist Church in El Salvador and discovered a deep sense of connection with a community far away. Together, we recognize a new level of lament as we share stories, but also lift up joyful singing that will ring in our hearts for years to come as we remember the ministry shared and friendships made. While participants paid their own way, the trip was made more affordable thanks for the regional council's Doing Mission Together grant and the generosity of our region's UCW.

In the spirit of partnering and working together, we are also looking at a new framework for our song. We are shifting to a body that spends time discerning important ways forward on issues that may not result in a decision, but will help us shape policy down the road. As a result, for instance, at the fall general meeting at Emmanuel United, Odessa we had a lively discussion around changes to the role and understanding of designated lay ministry in the United Church, in response to new decisions by GC44. Our regional council now makes space for DLMs who have retired from active duty to maintain their license to marry by becoming voluntary associate ministers. When the Manual allows, we will also invite those who have retired from active ministry to maintain their membership in the regional council, giving them full voting rights without being a representative from a pastoral charge. This also means, that the chorus of ordered clergy has expanded its membership, inviting DLMs who are in active ministry and who qualify,

to consider ordination. In fact, we will be raising some wild hallelujahs at our April meeting as we ordain Brian Nicholson, DLM.

In our improvisational moments we also discerned a new communications / advocacy approach, and that is one song that is still finding a melody!

As a body that recognizes the values of all peoples' songs, we discerned a strategy to help communities of faith see the importance of the Remit that has been before the church, making space for an autonomous indigenous church. These conversations led to a team of callers who reached out to every pastoral charge that had not yet submitted a vote, reminding them of the importance of voting. The voting rate in our regional council is higher than the national average, and we are delighted to know that Remit 1 passed.

Our orchestra has discerned ways to make sure everyone is heard and valued at our meetings, by introducing an equity score card. This is an online tool created by the equity team, available to every single pastoral charge or regional team to help guide equity support during meetings, and to help evaluate our work at the end.

The framework keeps shifting, and that is ok! Over the year we became intentional about that framework. Our governance model was created in 2019, hoping to provide an organizational structure that recognized fewer volunteers, greater geography, a new way of relating to each other through regional councils instead of presbyteries and conferences... but before we could test the new framework, someone pulled the plug. The pandemic required all of us to sing unaccompanied, in rooms by ourselves, even if we could see our fellow choristers on a screen. Adapting to the reality of a pandemic meant we never had a proper chance to test our new framework. The discernment now is difficult, not knowing what failed because of covid, or what simply did not serve the particular voice of this regional council. You will see before us now, is a possible framework, with adjustments made that could help us to sing with more confidence, building more and more trust that can make our song a surprising and beautiful thing.

I want to introduce the assembly of elders to you now. It is has been my honour to work with the following people this past year, and I value each of their gifts, their particular perspective and experience they bring to our choir! Please note that with the resignation of Rev. Lesley Hamilton, the regional council elected Joyce Payne to the assembly of elders at the fall meeting: Stephen Coles, Margaret Curtis, Rev. Kevin Fitzpatrick, Brian James, Patricia Long, Ted Meyers, Rev. Kaitlyn Ostrander, Joyce Payne, Rev. Paul Reed, Bill Sheaves, Rev. Lynn Watson Rev. Ned Wells, as well as staff members Rev. Éric Hébert-Daly, Sharon Hull, Rev. Darren Liepold, Joel Miller, Rev. Rodney Smith-Merkley, and Karen Wilson

With the rise of the spring meeting, the terms of Margaret Curtis, Ted Meyers, Rev. Paul Reed and Bill Sheaves come to an end. I personally want to thank each of these people. When we experienced staffing shortages two years ago because of illness, each of these people became invaluable staff resources themselves, ensuring the work of pastoral relations continued, so communities of faith could continue to evolve as the spirit called. I'm not sure what words would be adequate to thank you for that time, and for the constant burden you have carried on all our behalves these past years. What comes to mind is Well done, good and faithful servants. I am grateful that Ted and Bill, who have held significant leadership roles and have been instrumental in making sure our orchestra is functional and continues to make music for the world... I'm grateful that you are able to continue to offer your support and expertise to the Regional Council. And Paul, you offered steady and confident leadership throughout Covid, when many of us were

wary of technology and unsure how we could possibly carry on. On behalf of the entire regional council, if I may be so bold, I want to thank you for the sacrifice of leadership.

As of writing this report, I don't know who our new assembly of elders will be, but each time we add a new voice to the choir, the music changes, the potential shifts, and the road ahead is hard to see! But I trust in the one who conducts this choir of diverse voices and abilities, and I know that there is stunningly inclusive and inspiring music ahead for us all!

As of the rise of this meeting, I am stepping back from my role on the assembly of elders and resigning as commissioner to General Council 44. I know there are powerful leaders among us who will step up, and we will continue to sing a new song unto the Lord!

May you be blessed and inspired by the Lord of Song who leads us to life. Amen.

ECORC Financial Update 2024

2022 Audited Financial Statements

The audited financial statements for 2022 have been completed and are included below. There were no significant changes for the draft statements previously received.

2023 Draft Financial Statements

The draft financial statements for 2023 follow. There will most likely be slight changes to allocations and some additional charges for invoices paid in 2024 but accrued to 2023. Total income for 2023 was \$841,806 which was primarily transfers from the GCO (General Council Office) for operating expenses, mission support activities and sales of church properties. The income from property sales was allocated to the property funds then transferred to other ministries in accordance with the property sale policies. Operating expenses including salaries and benefits, grants, meetings and travel, archives, etc., totaled \$647,395 resulting in a net revenue of \$194,411. The net revenue for the year after investment returns are added was \$205,118. The excess funds are allocated to the Community of Faith assistance fund to provide grants or loans to communities of faith once that is set up.

A couple of churches were closed as they had run out of operating funds with little hope of covering expenses. The Regional Council is covering the operating costs to keep the buildings heated, insured, etc., until they can be sold or taken over by Kindred Works. These costs will be recovered from the sale proceeds.

Current Year financials vs budget

There are two primary sources of income for the operating and grant expenses of the Regional Council, Assessment Revenue and Mission Support Allocation.

The assessment revenue comes from the yearly assessments charged by the General Council and is used to cover most of the operating costs of the Regional Council including most staff expenses, office rent, semi-annual meetings, covenant support activities, and other administrative expenses. The first quarter (Jan 01 to March 31) transfer income was \$102,910 plus \$32,744 for designated gifts. The budgeted first quarter expenses were \$122,553 while actual expenses were only \$80,964 due to contingency allocations not being required and the new minister not yet hired.

The Mission Support allocation comes from the donations to the Mission and Service Fund of the United Church plus designated gifts and property income fund. The allocation for the first quarter was \$45,000 and the amount transferred was \$39,443. There were also designated gifts of \$36,863 and property fund income of \$33,400 for a total income of \$109,706. The expenses are the costs of staff specifically allocated to Mission Support, Mission Support grants, Doing Mission Together grants and Formation, Nurture and Justice team costs. Total expenses to date are \$116,693 resulting in a deficit of \$6,987 primarily due to unbudgeted restricted fund payments.

The Mission Through Property and Finance Team has been working to set up a Community of Faith Assistance fund for some time. The challenge had been keeping the fund and its control on the Regional Council books to the satisfaction of our auditors. The process was re-set when new auditors were brought in but are moving forward again. Erik Mathesen, Executive Officer, Finance, has agreed the GCO is setup to handle such funds and activities and is working to obtain GCO Executive approval.

The Regional Council is currently in a good financial situation and should be able to provide the necessary oversight and assistance as well as some financial support to Communities of Faith.

Office of Vocation Report to East Central Ontario Regional Council

Greetings from your Vocational Minister, Rev. Caroline Penhale. Thank you for the invitation to share with East Central Ontario Regional Council information about the ministry of the Office of Vocation in Quebec and East Ontario in 2023.

From January to June of 2023, I shared this role with the Rev. Lillian Roberts. Up until that time, I was focused on our Candidacy Pathway. In this capacity, I served and still serve as the staff resource for the Quebec and East Ontario Candidacy Board as it accompanies applicants and candidates discerning and preparing for ministry. I also connect regularly with candidates and applicants at various stages of their formation for ministry in The United Church of Canada.

In July of 2023, I assumed the full role of Vocational Minister for Quebec and East Ontario, therefore expanding my focus to include all the ministry personnel in terms of oversight and accountability across three regional councils: East Central Ontario Regional Council, Eastern Ontario Outaouais Regional Council and Nakonha:ka Regional Council. I work cooperatively with the Pastoral Relations Minister in each region. I approve the requests of ministry personnel asking to be available for call or appointment, and I provide letters of good standing to ministry personnel when needed. I am also available to candidates and ministry personnel who have questions and could use support, especially in matters related to their vocation or to policies of The United Church of Canada that directly impact ministry personnel and candidates.

The ministry of the Office of Vocation is supported by volunteers from East Central Ontario Regional Council who serve on the Quebec and East Ontario Candidacy Board, the Admissions Board, the Board of Vocation and the Response and Remedial Committees. I am humbled and grateful for the work that these board members do for the benefit of all who seek to lead and serve in The United Church of Canada.

2023 was a busy year for the Quebec and East Ontario Candidacy Board, which met 8 times either to engage in the administrative work of the board or to interview applicants and candidates. Over the course of these meetings, the Candidacy Board worked very hard to conduct 44 interviews with applicants and candidates across its three regions; 13 of those interviews were with individuals from East Central Ontario Regional Council.

As The United Church of Canada continues to live into its mission of "Deep Spirituality, Bold Discipleship and Daring Justice", the Office of Vocation continues its important work: to support effective, faithful and accountable ministry formation and leadership.

In the coming year, it is my intention to create more opportunities for applicants and candidates across Quebec and East Ontario to connect with one another so as to share in the joys and challenges of the Candidacy Pathway. To that end, I have begun hosting monthly Zoom calls so that candidates can get to know one another.

Finally, I wish to close with an invitation: please do not hesitate to contact me if you have questions about matters of accountability and oversight such the interpretation and application of the Workplace Discrimination Harassment and Violence Response Policy and the Sexual Misconduct Response Policy and Procedures; the requirements to remain in good standing, or anything pertaining to a candidate's journey through the Candidacy Pathway.

Accountability Report to Regional Councils – Origin: General Council Executive & the General Council Offices

Greetings as you convene for your annual meeting. We pray that it will be a meaningful time of gathering and work as you visualize what it means to be evolving communities characterized by deep spirituality, bold discipleship and daring justice. We recognize the challenges to our collective ministries as we imagine the sustainability of the ministries of The United Church of Canada and acknowledge the necessity as leaders to be harbingers of hope. We join you in the journey.

The Executive and staff leaders in the church have committed to find ways to enable the ministries of the Communities of Faith. This report highlights four initiatives that will significantly impact our communities.

UCC Protect United

This initiative is by far the largest financial commitment of the strategic plan, with a \$3 million loan funding a captive insurance program aimed at helping participating United Church ministries first reduce and then contain insurance costs. In addition to providing the start-up capital, the national church is also exposed to providing more capital in the event of particularly adverse claims results - especially if they happen in the early years.

The program was rushed into place for December 2022 to provide immediate premium relief, with a rollback of premium increases from 2020 and 2021. This meant premium reductions of 11-27% during a

year when insurance premiums in the industry were going up by 15-30%. Even with a premium rate increase in December 2023, on an apples-to-apples basis, participants paid less for insurance than two years prior.

So far – repeat: so far – the program has been a success financially. Annualized premiums paid for 2021-2022 were \$10.1 million versus \$8.1 million for the first year of the program – a saving of almost \$2 million when adjusted for new business and closures/amalgamations. The interest on the start-up loan is being paid annually. Claims experience has been well within target levels, and with each additional year of reasonable claims experience, the captive insurance arrangement becomes more self-sufficient and the start-up loan potentially repayable.

Despite the very encouraging <u>initial</u> financial results, the customer service and administration has been very poor and caused much frustration for participants. Much of this was attributable to rushing the launch of the program to deliver the financial benefit, but our partner's existing systems and staff proved inadequate for the volume of queries that arose. Church-side decisions to deliver more savings also proved challenging administratively. There has been much remedial activity underway, and we expect to achieve proper service capacity by the second quarter of 2024. We will launch greater coverage flexibility and improved communications at the same time.

Everyone is reminded that this initiative will need to run just like a traditional insurance company, with claims administered accordingly. The difference is that we are all in it together to try to reduce risk and claims – and therefore premiums. This captive insurance arrangement exists solely to benefit participants.

Strategic Operational Plan Initiative - Growth

All the Growth Animators are now in place, working actively with regions on their strategies for renewing and creating communities and inviting strong participation in The United Church of Canada. In January and February alone, Growth Animators met with:

- 71 Ministry Personnel
- 37 Governing Bodies (by phone, online or in person)
- 16 Communities of Faiths, and facilitated
- 31 conversations about Growth to some form of regional body.

The focus of these meetings has been visioning; collaboration with other Communities of Faith; exploration of neighbourhood profiles; creation of renewal or growth strategies, and exploring practices of discipleship and invitation. Staff continue to explore and develop possibilities in 40 possible sites for new Communities of Faith amongst migrant, diasporic and Francophone communities; close to 10 of these are sufficiently developed to have leadership contracts to support their continued progress.

Collaborative Ministry Models

There are many different models of collaborative ministries that already exist in the United Church. Work is underway to develop and offer training programs for lay leaders and ministry personnel in collaborative ministries, and those who might be interested, including candidates for ministry. Faithful Footprints

To date, we have invested almost \$3M in this initiative to assist Communities of Faith in upgrading and renovating their heating/cooling systems and addressing issues of environmental sustainability and cost savings.

Other Updates

Addressing Structural Opportunities: These initiatives are a critical part of the ministry of the leadership team consisting of the Executive and staff leaders. We invite your continued engagement in these areas of work. There are several other initiatives to address some structural opportunities, and responses to emerging issues. We have established working groups to provide additional critical information as we address the challenges of sustainability. We established a Total Compensation Task Group to look at the issues relating to the church's compensation challenges. In keeping with the commitment to evaluating the 2019 structural changes in the church, a Steering Committee has been established to work alongside Cheryl-Ann Stadelbauer-Sampa, the staff lead for the project. Both groups will be reporting to the 45th General Council in 2025.

In keeping with *The Manual* requirement (*D.4.1.6*), the Executive has established a working group to review the role of the Moderator. Additionally, the Executive agreed to also include the role of the General Secretary in this review.

The Ministry of Justice: As we continue to live into the commitment to becoming an antiracist denomination, we have introduced a new initiative, *Equity, Diversity, and Anti-Oppression Education for Committees*.

To date, most committees have completed, or will soon be completing, their education sessions. From the feedback so far, we hope to offer similar programs more broadly to other leadership groups in the church. Together with the Indigenous Church, an *Indigenous and racialized youth gathering* is now into its second year. This now-annual gathering is firmly lodged as an emerging youth-oriented community of faith. It focuses on building understanding through mutual learning on experiences of racism and creative responses to antiracism in the United Church.

Finding ways to invite a deeper and a broader engagement in advocacy continues to be a challenge, especially when the church is not of one mind and often is unable to speak together in respectful ways across our differences. There have been two new hires in the General Council Office, a *Government Relations Officer* to help to build our capacity to engage with government as we deepen our advocacy efforts, and a *Program Coordinator, Global Advocacy 2SLGBTQ1A+*. In addition, we have developed a new advocacy tool to enable sign-on as part of any advocacy campaign. The Justice Principles adopted by the 2023 annual meeting of the 44th General Council has provided a framework for our advocacy particularity with the war in Gaza.

Together with the Indigenous Church, the work on justice and reconciliation continues as we attempt to address both the Truth and Reconciliation Commission's (TRC) Calls to Action and the Calls to Justice of the National Inquiry into Missing and Murdered Indigenous Women, Girls, and Two Spirit People. Communities of Faith are invited to witness for justice in this area; this includes the Moose Hide Campaign and our *own #SearchTheLandfill* social media campaign regarding the Brady and Prairie Green landfills in Winnipeg.

The Executive invited the *Theology and Inter-Church Inter-Faith Committee (TICIF)* in collaboration with the Indigenous Church and the Anti-Racism Common Table to examine the use of the word "mission," given the colonial history of the word and to bring recommendations; these were adopted in November 2023. (The proposal <u>GS 63 Recommendations re: Mission</u> is found on the <u>United Church Commons</u>.) Following the request of the 44th General Council, a working group was established to engage the church in learning about and countering antisemitism, particularly within our interpretations of Scripture, in

worship, and in Christian education. More information and resources can be found on the <u>Countering</u> <u>Antisemitism page</u> on the United Church website.

Centennial Celebration: Planning for the United Church centennial is underway. There will be three streams:

- 1. Commemoration
- 2. External-focused communication and action plan
- 3. Fundraising/capital campaign.

June 9, 2024, will be the launch of the centennial year (online and in person) with a worship service at Metropolitan United Church, Toronto, a site close to the inaugural gathering at the former Mutual Street Arena. Every month, from June 2024 to June 2025, a key moment will be highlighted on social media to mark and share our history. The date for the Centennial service itself has been set for June 8, 2025. This will be the celebration to which we invite international guests.

The goal of an external-focused campaign is twofold: to introduce the distinctiveness of the United Church to those who have only a broad umbrella definition of "church," and to reconnect with those who claim United Church identity but have lost connection. The Executive asked The United Church of Canada Foundation to lead a legacy campaign.

Mission and Service: Good news! We are grateful for your continuing support of the collective ministries of the Church. There is good news to report regarding the 2023 Mission and Service results: contributions by congregations, United Church Women (UCW), and special donations all exceeded budget. The totals for these three areas, sitting at \$17,090,056, were slightly over the 2022 actuals of \$17,062,694.

The total for Mission and Service from all areas was \$20,831,564. This compares favourably to the total budget of \$20,225,000, and is close to the 2022 actual amount raised of \$21,132,213. These are preliminary results, and you can expect a final tally and the Mission and Service Accountability Report in June.

Greetings from the Nominations Team.

As everyone in the Region is aware, the majority of the work of the East Central Ontario Regional Council's ministry is accomplished through the dedication and passion of many volunteers. It is the work of this Team to encourage participation in the ministry of the Region, to seek out those who would like to volunteer, and then to discern how best to deploy the gifts offered.

The rhythm of our work follows this basic timeline:

In early February we meet to evaluate how many new members each Team needs. Then we check-in with the chairs of each of the Teams to ensure we have the correct information and, importantly, to find out from them the particular gifts they are looking for in new members in order to round out the skill-set required to live into their Team's mission most fully.

Nominations were open this year from March 1 to March 15 and, in that time, we received 14 expressions of interest to fill 20 positions. Once the forms were collated, the Team met by Zoom on March 19 to do our work of discernment.

In our discernment process, we consider several factors for each candidate and Team, with the aim of achieving a balance with who is already on the team, what gifts people bring to the role and recognizing a diversity of life experience and geographic location. An important next step is to pray. This time we prayed over each name in silence. Our Team members found the time of silent prayer to be a very powerful experience.

Some comments from this year's process:

- 1) All members of the team expressed concern over the low numbers of applications.
- 2) The team discerned that there is no conflict of interest among the applicants.
- 3) We were curious as to why only men applied for Mission through Property and only women for Faith, Nurture, and Justice.

A wondering: How do we as a Region encourage more people to participate in the ministry of the Region?

A recommendation: We recommend that each chair of each Team plan for their succession.

Covenant Support Leadership Team

Overseeing: Retirees Forum, Licensed Lay Worship Forum, Liaisons Forum

Hello everyone and God Bless. I am Bill Sheaves and I am the chair of the Covenant Support Team. Rev. Darren Liepold is our staff associate.

We have primary oversight of the pastoral relations processes as well as assisting in various time of conflict and difficulty in pastoral charges. We meet monthly except for the summer.

One of our main responsibilities is the consideration of every call and appointment in the Region. We review and recommend approval to the Assembly of Elders, who take our recommendations as further evidence of a suitable call for a particular Pastoral charge. In addition, we oversee the work of three forums: Licensed Lay Worship Leader forum (LLWL's), Retirees Forum and the Liaison Forum.

We interact with the LLWL's on both a formal level and informal level. We vote and recommend for appointment the candidates to be licensed. We also bring them together for mutual support and education events.

The Retirees Forum is primarily a body of collegiality and support for retired ministers who hold a vast knowledge and experience over decades together over the past year. It is the body that takes on the region's responsibility to care for and support a retired minister and retirees from other United Church work.

The Retirees Forum is the leadership team for the Retirees Network (composed of all the retired United Church ministry personnel in the East Central Ontario Regional Council). We are part of the ECORC Covenant Support Team. There are about 160 retirees. Our purpose is to provide opportunities for retired ministers to connect with each other for purposes of mutual support, discussion about theology, church issues, or any other topic of interest.

We have had monthly Zoom gatherings (open to all retirees) on topics including United Church Pensions, the Regional structure, joys and challenges of our ministry experience, and sharing personal burdens.

We have a chat group on Facebook through which retirees can address topics which are of joy or concern to them. And we have a list of retired ministers who are available for pulpit supply etc. A list is available through Rev.Caroline Giesbrecht.

Our ministry retirees have a wealth of experience and knowledge (maybe even wisdom!) to share, so if anyone has ideas of how we might be helpful to the church and its communities, please let us know. We can be contacted directly or through Karen Wilson and the ECORC website.

The Liaison Forum, chaired by Steve Coles, provides support and education to the Liaison persons who provide front line support to the pastoral charge during ministry change. The process outlined in Churchhub.ca is the basis for this ongoing work.

Although we continue to meet on ZOOM we are now able to meet in person with Communities of Faith that are having conflict. We hope that the CST can continue to have a deeper interaction, encompassing our Region's commitment to being, affirming and anti-racist Church.

All Calls and appointments are now recorded on ChurchHub. The Pastoral charge approves a call or appointment (usually at a congregational meeting). This decision is then written up on the appropriate form for calls or appointments on ChurchHhub.

Once accepted this form is transmitted to the Minister, who has been selected on the form and based on their request through ChurchHub, to be made available for search. The Minister then must agree and approve their Call.

When the two approvals have been received, this Call or request is then placed for evaluation before the CST and finally the Assembly of Elders where it is approved. The final approval is up to the Region.

ChurchHub will publish via email the approved form of all those who have agreed to the Form. Once this confirmation is received, covenanting services can planned with the Liaison who has worked with the pastoral charge.

Licenced Lay Worship Leaders (LLWLs)

The year 2023 was a very productive year for the LLWLS in the East Central Ontario Region and 2024 is off to a busy start.

There are now 30 approved LLWLs in the Region with two more approved to be tentatively added by June. Twenty-five are presently available for pulpit supply in communities of faith other than their own home church.

There are six members on the LLWL forum (two clergy and four LLWLs), plus Karen Wilson as ECORC staff rep. There have also been some substantial additions to the Forum (and Network ECORC website over the last year with more upcoming. Rev. Cathy Gradante is the Chair and Paul Kneebone is the Secretary. The LLWL forum met six times and plans for at least four times this year. This year we have seen the retirement of the Rev. Cheryl McMurray and she leaves with our sincere thanks.

All LLWLs and individuals presently in the LLWL online course of study are all members of the LLWL network.. The in person meetings are a great opportunity to socialize together and share a lovely lunch and conversation.

Thanks to Rev. Darren Liepold for his assistance with this team. We are committed to the well being of the Region.

Indigenous Justice And Respectful Relationship Forum (IJRR)report

Our forum has been fortunate to have Elaine Kellogg as chair for several years now. Elaine is stepping away from this position, and we will miss her leadership. A new addition to our group is Michelle Adams, representing the UCW. She joins Jackie Harper, Sharon Hull, Katlyn Ostrander, Rodney Smith-Merkley, Shelley Knott-Fife, Elaine Kellogg, Mary Anne MacFarlane, Helmut Enns, and Ned Wells on the forum.

Our forum continues to look for ways to support local congregations, provide resources, and also to share information about events not hosted by ECORC, events which can lead to justice and respectful relationships.

Getting out the vote for Remit 1: Establishing an Autonomous National Indigenous Organization has been a major focus this year. We are pleased that most communities of faith in ECORC have submitted their vote.

The travelling library is now a reality. In fact, we have 3 travelling libraries. These 3 libraries focus on IJRR. We invite other forums to create libraries as well. Each set of 3 cases contains children's books, novels, resource books and more. The libraries have been in several churches, and one is ready to be relocated to your community!

IJRR has initiated ZOOM "Gatherings for ECORC Communities exploring Right Relations." This is an opportunity to ask questions, share initiatives, and find ways to work together.

Sharon Woodrow would like to host a witness blanket in the Cannington church. See Witnessblanket.ca for an explanation. Sharon is planning to have the display available to schools and churches. The target date is September to October 2025.

All of us on the Indigenous Justice and Respectful Relationship Forum are more than happy to meet with you to assist in any way possible with this work in your local area. We look forward to hearing from you. Submitted by Helmut Enns and Rodney Smith- Merkley

Affirming Forum

We would like to recognize and thank Rev. Elizabeth McDonald for her vision and leadership of the Affirming Forum since its inception in 2019, and to Sharon Woodrow for her tireless efforts as secretary. We will strive to build on the excellent contributions both of these women have given to the work of Affirming.

The Affirming Forum met 9 times in 2023 with 6 members, and staff member Sharon Hull.

Our goal is to provide a safe space for all and encourage folks to not be complacent. We recognize our social climate is changing and in fact is becoming dangerous to many in the 2SLGBTQIA+ and Trans communities.

We sponsored 4 zoom networking gatherings, inviting interested folks from Affirming communities of faith, those in the affirming process and those who might be interested in starting the process. We discussed the implications of the September 20 right wing protests, and how these events might or have been harmful to our communities of faith. We continually share links to resources from Affirm United and Affirming Connections that could be helpful to groups planning discussions, events, etc.

We promoted PI/PIE Day, March 14, offering support and encouragement to have local events happen. We led worship at the Spring Regional Meeting May 5 and 6, with liturgy written by Rev. Michelle Down, a member of the Affirming Forum. Included in this worship was the dedication of a table runner for the region's use. Several regional progressive flags were handed out to representatives from Affirming communities of faith, and these continue to be given to communities who achieve a public Affirming presence.

A presentation regarding pronouns and their importance was given to the Assembly of Elders in October 2023.

As our social climate continues to change, the Affirming Forum is committed to providing safe space for discussion, and physical support at community events. We are committed to growing the network of folks who are passionate about Public, Intentional and Explicit advocacy for all to be treated equally with respect and dignity.

We may find a better time for more to gather together. There has been good participation in the south west area cluster (see info below) and the leaders (project partners) gather together on zoom.
- New cluster in the south west area of the RC:

Community Youth Project- Westminster United Church received government grant money to research and design a children/youth program. Susie Noorlander was hired as the Youth Ministry Initiative Lead and other communities of faith in the area have been invited to partner. Anti-Racism, Interfaith, Intercultural Forum

As the East Central Ontario Regional Council's Anti-Racism, Interfaith Intercultural Forum plans its agenda for 2024, we take this opportunity to inform you of all that has been accomplished since the Region's policy regarding Anti-Racism was approved on April 30, 2022.

RESEARCHED EVIDENCE FROM CHURCH, AND COMMUNITY

Internal survey results from 52 (fifty-two) congregations received, revealed the fact that we have 23 (twenty-three) different languages spoken amongst various members/adherents in our communities of faith. This highlights wider and deeper intercultural legacies in the East Central Regional Council. Regarding areas of support requested by communities of faith, there are written requests in the following categories:

- 1. Education in Cultural and Religious literacy
- 2. Information on strategies for making connections with and interacting with our neighbours
- 3. Training in various formats
- 4. Resources general
- 5. Resources for worship.

ORGANIZATION OF CHURCH, AND COMMUNITY GATHERINGS

- 1. Leadership Summit on Inclusivity
- 2. Leadership Summit on Anti-racism which brought the following written comment from the former Chair of ECORC'S Justice Committee, the Rev. Meggin Hare "the part of this gathering that spoke more strongly to me was the opportunity to hear from over half a dozen other community leaders, from the realms of business and health and education. I was so gratified to see how the work of anti-racism is being recognized for its importance in such a variety of realms. We are becoming more vocal in naming the issues of racism endemic to our communities; to name our complicity, conscious and unconscious; and to acknowledge the continuing work we need to do"
- 3. Leadership Summit on Community Conversations
- 4. Training event on Unconscious Bias and Microaggressions with Dr. Sheila Wilmot

- 5. Regional Pentecost celebration of our Anti-Racism Policy

Mission Through Property

This past year the Mission Through Property Team and ECORC have been very busy with discussions about the future of church properties of many COF's as they struggle to find options for their survival. Rising operational expenses and declining memberships have forced many to consider their futures. In support of these COF's ECOR has been working with them to consider alternatives to help with escalating expenses. Many of our church buildings require age related capital expenses. New demands by the insurance industry have created expenses for capital improvements and without these improvements insurance coverage may not be provided. Environmental improvements, handicap access and other gov't introduced requirements all contribute to these escalating expenses.

We work with COFs to consider expense reducing options like shared ministries, Group insurance coverages (Director and Officers) through HUB of the United Church of Canada are just a couple of examples. We are always tracking what grants might be available to assist with expenses. We along with Kindred Works, work with COF's to consider whether Development opportunities for their properties might provide a income source for the future. Just a reminder that Kindred Works solutions are not quick fixes and will often take several years to become a reality.

We manage the M&S grant applications along with our own Doing Ministries Together grant applications. If you require more information about what else might be available, please contact us or refer to our website.

We also work with COF's in other areas of support of their needs. Some of these are: lease arrangement's for COF's; capital projects \$50k or greater; emergency repairs; cemetery issues as requested by GBO; operational expenses; insurance challenges

Land Trusts

This past summer Land Trusts were introduced and approved by the authorities which allows Kindred Works and ECOR to hold properties in a trust fund which allows for the collection of significant assets for future uses like housing projects and new Church ministries. When COF's declare that Church properties become surplus to needs as a result of closures, mergers, disbandment's and amalgamations three options are considered;

- Kindred Works is given the first option to hold these assets for the development of housing projects and they assume the property management responsibilities.
- ECOR then has the option to hold these properties for future needs and they take over the property and the property management responsibilities. In both of these options it is assumed that these properties can operate where rentals and third-party usage can generate enough income to offset the expenses. If this isn't possible then.
- The properties are listed for sale and proceeds are distributed as per the current ECOR polices.

Amalgamations or Disbandment's and Sales - Property Disposition

Mentioned here are the current amalgamation's - sales for your information.

- Insgoldby United Church amalgamated with Haliburton United Church Jan 1st 2024 Insgoldby United Church sale closed April 8th 2024.
- Plainsville United Church Amalgamated with Camborne UC of the Cold Springs Pastoral charge Jan 1st 2024. Planning for the Sale of Plainsville UC are currently underway.
- Penial United Church amalgamated with Woodville United Church Penial UC is currently in the process of being sold.
- Zephyr United Church is amalgamating with Sandford United Church effective Nov 1st 2024. Planning for the disposition of Zephyr UC is currently underway.
- St Andrews United Church, Beaverton, amalgamated with Trinity United Church, Cannington as of April 1st 2024. St Andrews United Church will be held by ECOR and property management Service are being provided by TUCC.
- Prince Albert United Church amalgamated with Port Perry United Church. July 1st 2023 The sale of Prince Albert UC is currently underway with a lease to own agreement in place.
- Highland Hills Manse sale . Closes April 18th 2024

Kindred Works and other Development Projects

This past year ECOR approved and or continued to support many Kindred Works projects. There are other projects at various levels of approval, and I mention a few for your information.

- Trinity United Church and Housing Development in Uxbridge. Project is actively seeking final approvals from the various gov't bodies and just received a \$2.75 million grant from Durham Region to build a 105 unit affordable housing facility. A new Church will also be built as part of this overall development. The original church was destroyed by the Tornado of May 2022,
- Dunbarton Fairport United Church developing 13 affordable housing units in Pickering, through a partnership with the United Church and CMHC. AHIP funding in the amount of \$1,950,000 was allocated for this project by Durham Region.
- Sr Stephens United Church Oshawa Housing Development. Disbanded April 30 2023. This project has been submitted to the municipality and is also seeking approvals for their project. KW is providing property management services.
- Bowmanville United Church Development. KW is working on the planning phases with various municipal authorities and have assumed the property management services for the current building.
- Simcoe St United Church, Oshawa, development. KW is currently working the municipal authorities on plans for a housing development.
- There are other projects at the feasibility stage and we continue to get inquiries from churches seeking information about future development opportunities.

ECOR approved the sale of a couple of other development properties for housing projects.

- Trinity United Church, Peterborough
- Mark Street United Church, Peterborough

Equity members continue to act as "Equity Support Person(s)" or as observers during the Regional Information Sessions and at the 2023 Fall meeting. Equity supports the Facilitation Team and the Assembly of Elders by informing them of any equity concerns shared with them in the various formats: email (ecorcequity11@gmail.com), in-person (Pink shirts at the fall meeting), or private messages during Zoom Virtual info-sessions.

Equity Scorecards have been created for both in person and online gatherings. Each team or forum is encouraged to have a member fill out the scorecards which provide feedback on the physical space, awareness of inclusive language, dietary considerations (if applicable) as well as taking into consideration other factors of accessibility and equity.

Other Equity initiatives include:

- ongoing work on a standard template for PowerPoint presentations.
- working with the Assembly of Elders to develop an online version of "Holy Manners" so that whenever we gather as a body (in person or via Zoom) we remember the way in which we are called to interact with respect, compassion and joy in our encounters.

 communicating to all teams and forums of the common practice that an Equity Support person is to be identified at the start of all meetings and before the meeting concludes, observations be shared with the meeting. If there are any concerns/actions/observations during these meetings, the Equity Support person is encouraged to inform the Team by using their email, <u>ecorcequity11@gmail.com</u>.

In addition to the actions mentioned above, we are committed to continue our personal learning. We are grateful to Rev. Dr. Elizabeth Cunningham who led us in a book study of Amy Kenny's book "My Body is not a Prayer Request." Amy's personal experience and stories speak of the need to address disability justice within the church and wider society. She encourages and challenges us to become more aware of how we might create spaces of belonging for all. A smaller group within Equity is developing a book study to be offered to interested parties within our Region. We offer thanks to Rev. Dr. Sharon Ballantyne who offers valuable wisdom and resources for us in the development of this study. Additional Reporting

Rural Connect

Rural Connect is an initiative of the United Church of Canada, which aims to partner congregations for interactive, internet enabled worship. The program brings the words "We are not alone" to life.

Originally under the banner of EDGE, the program is now under the Growth and Ministry Development, Organizational Development and Strategy Unit. Rev. Bronwyn Corlette, Rural and New Ministries

Coordinator, is the program connection while the Rev. Randy Boyd continues in his role of hosting weekly support meetings for participating congregations.

The basic outline of the program is the connection of satellite and hub sites for shared worship. A hub is a location that provides the technical leadership for the worship service, having the equipment necessary to connect up to four locations for shared worship. There are two hubs located in ECORC: St. Mark's Cannifton and St. Paul's Bowmanville. Each of the hubs has invested approximately \$45,000 dollars to the installation of equipment for this ministry, and trained members of the community of faith in its operation.

Satellites have an all-in-one box with all the equipment they need. If you can turn on a computer, make a call on a cell phone and adjust the volume on a radio, you have all the technical skills needed to operate a satellite box. There is a cost recovery charge for participating.

All sites can share in worship to degree they wish. Everyone may share announcements, readings, prayers, music, preaching in real time. Over time, congregations build relationships through the sharing of worship.

In the past couple of years, several congregations have trialed the experience with St. Mark's Cannifton and Roslin Thomburg working together for approximately a year.

United Church Women (UCW)

Since the last ECORC meeting, the regional UCW has seen some significant changes.

The Regional UCW is divided into UCW Areas which match the former presbytery boundaries. There are currently 5 Area UCWs in our region: Lakeridge, Hills & Shores, Kente, Kawartha Highlands and Shining Waters. In 2022 we had 1720 members, the most of any of the 16 UCW regions across Canada. In that year we saw the closing down of Four Winds Presbyterial Area UCW which had tried for a number of years to find people to take on leadership roles. In 2023 was our first full year without our members from the Four Winds Area; however, individuals from that Area continue to serve the broader UCW and several have positions on the regional UCW. In 2023 we had 1250 members.

When women join the UCW in their church, they are broadening their circles and becoming connected as members of their Area, Region and the National UCW. Area UCW executives arrange from 2 to 4 major gatherings each year, promote our mission projects, provide regular communications to local UCWs and assist them with archival work. When a local UCW makes its decision to close, the Area UCW that provides advice and assistance, including a beautiful closing service which members of the presbyterial often attend. Opportunities for amalgamating with other UCWs or individual memberships are also made available. The presbyterial Area presidents all sit on our regional executive which meets in Norwood three times a year.

In September, we moved from the previous name "Bay of Quinte UCW ECOR" to become East Central Ontario Region UCW, a name now on our updated logo. We are an affirming ministry and you will see that rainbow logo and the Affirm logo on all our event announcements

Whenever we gather, the Spirit shines. Thank you to Kente Area for hosting the Annual; to Shining Waters for Quin-Mo-Lac Weekend where we were all "Moved by the Spirit" with drumming, the blanket exercise and presentations/activities on an indigenous theme. Thanks to Nancy Sutherland and Freda Burns, the fall leadership workshop drew in new faces to learn about "Then Let Us Sing." Shortly after, with great spirit in Kawartha Highlands Area, came Midweek, filled with fellowship and fun as we learned about how to care for creation and backyard birds. UCW events are all self-supporting with participants paying the full cost of the event. In addition, each event raises funds through roll calls or offerings for United Church programs or local charities.

We have ventured into several new paths this year. This is the first year of our Five Year Mission Project to support Indigenous Women, Children and Families through the United Church Healing Fund. Our first Healing Fund project has been a program of the Regina Native Outreach Ministry to provide Welcome Baby bags for indigenous women with a message that they do not walk alone.

We also returned to some roads walked before: supporting Student Candidates for Ministry with gifts from our Bursary Fund; selecting Lyn Miller as our UCW rep on the ECORC Pilgrimage to El Salvador in March 2024. We continue annually to support Old Hay Bay Church, Camp Quin-Mo-Lac and M&S. Across Canada, UCW donations to M&S for 2023 were \$494,217.60.

And we found some new ways to get the work done. With joyful hearts and many hugs, we returned to a full calendar of UCW Gatherings, but kept ZOOM meetings that ease the workload for planning teams and broaden the circle through online book studies. We thank Sharon Hull for leading a training session to support event registrars from each Area to take advantage of on=line registration. Many creative minds provided ideas to ease the load for organizing our September Quin-Mo-Lac Weekend. Going forward we will share the load; each year two Area UCWs will plan program and others look after registration and 'logistics.' Willing volunteers showed that this gathering is a highly valued spirit booster for our women!

We have held 5 online book clubs over the last few years, they most recent in February 2024 had 27 registered including a few guests from the Maritimes region, BC, and Florida. The UCW builds and maintains links across the regions. Members of the EOOR region to the east have attended both the book clubs and each of the Area Annual meetings held over the six weeks. Five are coming to the upcoming Regional Annual at Courtice on April 23 with the theme: Making a World of Difference.

We thank Karen Wilson for posting notices of our events and creating a UCW section on the ECORC webpage. Still in its early days, you can find UCW items by going to About Us...Ministry Teams...ECOR UCW News and Events. In addition, Helen Cox, our regional UCW Social Media Portfolio lead, takes photos and posts event notices on our Regional UCW facebook page. Take a look, as others have from across Canada, and you will see the light shining in East Central Ontario Region UCW. We are blessed!

Prayer Shawl Ministry

The Prayer Shawl ministry of East Central Ontario Regional Council provides shawls for new and retiring ministers, new staff and pastoral care. This year 9 shawls have been prepared for presentation at the ECORC Spring Meeting and others have been provided for pastoral care throughout the year.

Women from all areas of the region create the shawls. Some are specially made by someone from the recipient's home area, but often we make them with just the general purpose in mind, knitting or crocheting our prayers into the stitches. This year a great number of the shawls were knit by members of both Anglican and Presbyterial churches who join in an ecumenical local knitting circle at Emmanuel United in Foxboro. They use the traditional alternating 3 stitch pattern to weave the Trinity into the shawl.

Those who create the shawls or others who are aware of this ministry are honoured to donate the yarn, our time and distribution costs that may arise. Each shawl takes 20 to 30 hours of work. We welcome donations toward the cost of the yarn.

Each Shawl is given with a blessing card from East Central Ontario Regional Council.

May the one who receives this shawl be wrapped in God's love, in good times and in challenging times, and may the recipient be granted strength, hope, joy and peace.

We feel blessed to be able to serve ECORC in celebration of milestone occasions and hope that those who receive the shawls will feel blessed by God's presence in their life journey.

The Annual Report of Old Hay Bay Church 1792

National Historic Site of Canada 2365 South Shore Road, Napanee, Ontario March 11, 2024

The church had a busy year.

At our spring meeting (April 17) motions were passed to: replace the roadside fence on the cemetery; to have a new Pilgrimage sign created; and have the 1811 boundary markers repaired/replaced as deemed necessary. Discussions for the Pilgrimage service took place, and the decision was

made to not hold a sunset service this year, due to the poor attendance last year.

The Church opened to the public on Saturday, May 20. Volunteer custodians kept the church open daily until late September.

In May, the Board regretfully received two resignations of Board Members. We thank Rev. Phil Wilson for his devotion to the church and his commitment to stay for the summer as custodian coordinator. We thank Jen Welsh-Wilson for her commitment to the financial commitment and the work on the Memorial Garden for long time trustee Kathy Staples.

A July 11th, meeting was held finalize the Pilgrimage Service and ask Board members to step into the vacancies. We also accepted a new trustee, Brian Windover.

The Board also accepted the quote to repair the plaster and paint the interior of the church. During this work, the custodians stayed on site to speak with visitors, while maintaining safety precautions. This work was completed by the Annual Pilgrimage service. The contractor also provided the Board with directions on how to maintain and care for the stairs, railing, wainscoting and floor boards.

Our two new display and storage cupboard arrived on the first day the painters were removing pews and starting preparations. It was a busy day for custodians and trustees.

In August our Annual Pilgrimage service was held inside (first since 2019) under the direction of Rev. Phil Hobbs. Our guest speaker was, Rev. Rosemary Lambie, who spoke about the important of the church and its relevance to today.

In September we were one of the stops for the Lennox & Addington Cycling tour. Although not a huge money maker it is a great opportunity to promote the meeting house to the approximately three hundred cyclists that stop and rest.

In our fall meeting we accepted Terri Schuler and John Candlish as new Trustees. The devotion of the custodians and Board of Trustees has been fundamental in getting projects done and the church being open for the summer months.

The cottage and cemetery had minor maintenance done, with planning started for the major upgrades to the cottage in 2024.

The church continues to receive support from local media outlets for all its public events. We use Facebook and our website www.oldhaybaychurch.ca for promotional and learning opportunities. Our publications are available at Books on Main, Bath year-round and at the Loyalist Trading Post, Conway during the spring – fall season. These partnerships have been beneficial in raising funds and promoting the church as a tourist destination. We paid for advertising on line and in the magazine Breakaway.

Our attendance was slightly lower than pre-Covid numbers, but custodians felt the visitors were more interested and stayed for longer visits. The reasons why they visit were varied. They seek information on the religious history and significance of the church, they search for family connections to subscribers, their connection to the drowning victims of 1819, preachers and families in the area, the unique architecture, and some as they are interested in 'churches '. The most common comment is the peace and calm they experience inside the church.

On behalf of the Board of Trustees I wish to thank Rev. Darren Liepold for his support as our Regional Rep, and the grant we receive from the United Church of Canada. We encourage you to visit. On behalf of the Board, please know that we will continue to do our part in protecting and promoting this historic site. Bedford House





A Community Ministry of East Central Ontario Region 11 in partnership with Greenwood United Church Peterborough supported by Mission & Service Fund, Seeds of Hope Foundation, Doing Mission Together Fund, and individual donors

Vision:

To create spaces where people of all faiths – and none – might engage in "sacred conversations" and experiments to co-create a community that is ecologically sustainable, socially equitable, and spiritually fulfilling. In 2015 the United Church of Canada called for proposals to start New Ministries. In Peterborough, Ontario, a tight-knit group of Christian social activists responded with a proposal to start a learning centre for Community Development that was faith-based- they named it the Bedford House Community Ministry.

They asked: How might a small, under-resourced,

group of people from a variety of faith streams – and none – make a significant difference in our community?

Lynn & Allan Smith-Reeve, United Church Ministers trained as Community Animators gathered community members to help them grow new relationships among participants from diverse socio-economic classes, race, gender, physical ability, and neuro-diversity.

The outcomes include:

- More than fifty participants in four Bridging Teams that resulted in bonds of trust and friendship who gather now as the **Neighbours Network** (supported by Doing Mission Together grant)
- Core Financial support received from all levels of the United Church

which then leveraged financial support from Foundations and Government sources

- Individual donors who supported each Bridging Team's core expenses
- Significant relationships built with Peterborough's social service and faith community network

And in the fall of 2024, we are excited to offer you... **"Bridging Poverty & Privilege; creating courageous spaces for community to flourish"** An online course delivered on the ChurchX platform

In a series of six workshops, Lynn & Allan Smith-Reeve will share the lessons learned, the practices that worked, the surprises, the stories, and the outcomes of our seven-year journey building community across class lines in a model called Bridging Teams.

The "Bridging Poverty & Privilege" course features: storytellers from participants offering their lived-experience; the various resources we've studied together; and includes discussion questions for reflection - whether you move through the course alone - or with a group.

We've been blessed to have been sponsored by all three levels of the united church of Canada.

While our UCC congregations are amazing examples of communities where gifts are received and shared...the business model of churches assumes that members have enough disposable income to contribute to that offering plate passing by every Sunday morning. and therefore, underresouced people, those without disposable income, don't really fit in well.

Our work is based on the simple observation that:

- Wealthy people tend to associate with other wealthy people.
- Middle class, well-resourced people tend to socialize with other well-resourced people.
- And, Under-resourced people, working class, precariously employed folks tend to hang with other under-resourced people.



Yet, isn't the good news of the gospel is that we all belong at the table? Our journey has been an experiment of creating community that is inclusive of folks from all socio-economic classes and walks of life.

In our Bridging Teams experiment, we've brought together people from different classes and together we've studied what keeps us apart – for instance, the Hidden Rules of Class – and as we've studied we've found that when we create a courageous – space for people to laugh together, eat together and tell their stories – the spirit shows up, conversations deepen - and sacred moments happen as authentic community grows.

Even though our focus has been socio-economic class differences and systemic causes of poverty, we've found intersections in our Bridging Teams with race, gender, physical ability, and neuro-diversity.

In this series of workshops, you'll learn about Bridging Teams, the model of community-making we've engaged in. Our hope is that you'll discover practices you can use to create courageous spaces in your

context - spaces where "sacred" conversations will deepen the relationships our communities need to thrive.

Our experiment may have begun with high hopes of helping people cross the bridge out of poverty, but along the way...and it's a long way across that bridge...we've realized that the more important (and Jesushonouring) outcome is "belonging". It's really all been about creating the space for relationships of belonging with folks from across spectrums of diversities, to grow and flourish.

Look for our course on the ChurchX platform. We call it "Bridging Poverty & Privilege; creating courageous spaces for community to flourish"

Annual Report to Ucc Regional Councils April 2024



Atlantic School of Theology serves Christ's mission by shaping effective and faithful ordained and lay leaders and understanding among communities of faith. We did this in a variety of ways in 2023. With students and alumni in every United Church of Canada Region, we bring together a community with an extensive understanding of the varied needs of the church. The Summer Distance MDiv continues to be the

degree with the highest enrollment bringing students together for 6 weeks of intensive learning in the summer and online, synchronous, and asynchronous classes in the fall and winter. In addition to the MDiv degree, we have United Church of Canada Students enrolled in the MA as well as 3 diplomas and a wide range of continuing education options.

2023 saw the soft launch of our Bachelor of Theology degree which includes a "Ministry Specialization" stream. We were pleased to welcome 7 students in the fall and anticipate an increase in enrollment in 2024. This degree reduces the barrier for those without an undergraduate degree who feel called to serve the church and want academic excellence at a bachelor's level combined with opportunities for practical experience serving the church. We are excited about the ways this may meet the identified needs of our founding parties. We value our relationship with the Office of Vocation and Candidacy Boards across the country as we seek to respond to the educational needs of the church for shaping effective and faithful leaders.

The Rev. Dr. Rob Fennell concluded his tenure as Academic Dean on the 1st of July and I have taken over the role for the next 3 years. The Presidential search committee concluded their work, and the Rev. Dr. Heather McCance began serving as President on the 1st of August. Like all educational institutions, we face challenges and the road ahead is not always clear, however, there is a spirit of optimism and a sense of renewal within our school community as we chart a path for the future. It is a joy to work with United Church of Canada students as well as those who support them within the administrative structure of the church and individual communities of faith. We welcome your input as we seek to serve the ever-changing needs of the church.

Montreal Diocesan Theological College

At Montreal Diocesan Theological College—widely known simply as Dio—we are now in our third year as an ecumenical institution following the integration of the United Theological College beginning in the 2021-2022 Academic Year. Our United Church Studies program remains strong and vibrant. We have a solid number of students at various stages of the candidacy process and are looking forward to welcoming several new ones in the fall. United Church worship is a regular part of our chapel life and we have welcomed several ministers from the Nakonha:ka Region to lead worship over the past year.

As we continue to deepen our integration as an ecumenical institution, we are renewing and expanding our programming. This includes:

- The Certificate in Bilingual Ministry Program and French for Ministry Intensive. In May 2023, we hosted the first in-person French for Ministry intensive week since the pandemic, taught by Clara Maranzano. It was a delightful week with an ecumenical student body, many of whom continue to meet online in an advanced discussion group centred on theology for ministry. The French for Ministry intensive is being offered again in May 2024.
- The Montreal Mission Internship. This program offers service-learning, vocational discernment, and theological reflection in community over nine weeks in the summer for young people ages 18 to 25. We had a successful offering in summer 2023 with several students from a United Church

background and are looking forward to the 2024 iteration. Applications are being accepted through www.montrealmission.ca. Interns receive a stipend of \$5000 for the program.

- Online open enrollment courses. The college routinely offers short (three to six weeks) online courses designed for adult education and lay formation, in both English and French. Our offerings this year have included courses or workshops on preaching, Medical Assistance in Dying, the prophets of the Old Testament, and United Church history and theology. We welcome conversation with people in the Nakonha:ka Region about how we can offer courses that meet the needs of your community of faith.
- Learning Circle for Admission Ministers. In May 2023, we offered for the second year in a row a week-long intensive learning circle for admission ministers to the United Church. This was an excellent time of building inter-cultural community, introducing newcomers to the church, and looking to the future of the church with hope. We will be offering a variation of this again in May 2024. It will be a 4-day course taught in French and focused on introducing (or re-introducing) the United Church through the lens of Canada's inter-cultural reality. All are welcome as you don't need to be an admission minister to join.

It is programmatic fruits like these that are the most compelling proof of our success as an integrated college to date. But part of the reason for considering integration was financial realities. While we still have work to do, it is good to report that the integration of our colleges has led to a position of much greater financial stability. We continue to be immensely grateful for the dedicated and faithful financial support of our ministry from so many people.

Just as the church is changing, so are we. After many, many years of faithful service, the Rev. Dr. Alyson Huntly will be retiring at the end of May. We are currently searching for her replacement. We are also currently looking at how we can respond to changes in theological education prompted by the end of the Designated Lay Ministry Program, as well as how we can support French-language programs that lead to testamur for ordered ministry.

Our ecumenical Board of Governors is currently engaged in our first strategic planning process as an integrated institution. We see tremendous possibility for our ministry from our base in a multi-cultural and bi- and multi-lingual city to support the United Church of Canada as we move forward at a time of great change to realize the strategic objectives set before the church and be a people of Christ's kingdom of justice and peace.

On behalf of Emmanuel College, I want to bring greetings to your region as you meet this spring season.

I pray that your meeting goes well and that you experience God's presence and blessing in this important work of the church. My name is HyeRan Kim-Cragg and it is my privilege to bring you greetings as Emmanuel's Principal. I hope to see you in person in the near future and share good news of Emmanuel College with you and hear good news of this region's wonderful ministry.

Faculty Compliment, Trauma Informed Pedagogy & Faculty on the Road

Last year, we completed three significant faculty searches, marking historical milestones for the Toronto School of Theology (TST) of which we are a part. Rev. Dr. Glenn McCullough joined as assistant professor through a partnership with Knox, a first in TST's history. Dr. Jenny Bright became Emmanuel's first assistant professor of Buddhist Spiritual Care and Counseling. The Right Rev. Dr. Carmen Lansdowne will be appointed as the first assistant professor of United Church of Canada studies at Emmanuel after completing her moderator's role in December 2025. Additionally, Néstor Medina was promoted to associate professor, and Pam McCarroll to full professor, holding the Jane and Geoffrey Martin Chair in Practical Theology.

This academic year, the faculty has engaged training in Trauma Informed Pedagogy (TIP), with monthly discussions involving faculty, staff, and Research Fellows. TIP emerged from student discussions in response to our EDIA stance, "DEAR" (Dignity, Equity Accountability, Responsibility) Declaration, and has been supported by grants from the Wabash Center and the Association of Theological Schools. We plan to host a TST-wide conference in May 2024 to share our insights and impact other theological schools.

The current faculty is keen to go out into different communities of faith to promote Emmanuel and share their scholarship and wisdom. Andrew Aitchison as Admissions Counsellor and Recruitment Coordinator will be a liaison connecting faculty with communities. Please let him know if your communities want to invite our Christian, Muslim or Buddhist faculty. That would be so wonderful.

The Indigenous Healing Garden Project

This project, which aligns beautifully with Victoria University's sustainability strategic framework and Emmanuel's commitment to right relations with Indigenous communities, is currently underway, thanks to an initial grant from the United Church Foundation's Seeds of Hope. Brook McKllroy, the architectural firm, has been commissioned to redesign the courtyard which features the Crucified Woman Sculpture. The proposed designs have received approval from the project's advisory committee in collaboration with the Indigenous Elder circle. We aim to begin construction this summer and anticipate project completion by 2025, as part of the UCC Centennial celebration.

Major Celebrations at Emmanuel College

In the next few years, there are several significant anniversaries we're eagerly looking forward to celebrating! Firstly, in 2024-2025 we'll be commemorating three remarkable milestones: the 10th anniversary of the Buddhist Focus in our Master of Pastoral Studies (MPS) program, the 15th anniversary of the Muslim Focus in the MPS program, and the grand 100th Anniversary of the United Church of Canada. In 2025-26 we will celebrate 30 years of the Committee on Asian/North American Asian

Theologies (CANAAT). Then fast forward to 2027-2028, which promises to be another monumental period, marking the 20th anniversary of the Master of Sacred Music Program and the 100th anniversary of Emmanuel College itself. Stay tuned for more information about these celebrations to come.

I envision our celebrations will incorporate multiple fundraising opportunities to establish scholarships, enriching our offerings and supporting marginalized students. Notable progress has already been made in securing scholarships. We proudly unveiled our first named scholarship for Buddhist students in February 2024. Efforts are underway to establish a Korean Scholarship, with an inaugural fundraising dinner held this past fall, and another planned as a music concert commemorating the 100th birth year of the Right Rev. Dr. Sang Chul Lee on October 26, 2024, at Willowdale Emmanuel United Church. Additionally, a special fundraising event is in the works to establish a scholarship for Queer students, scheduled for November 2 for Drag Show paid event, in collaboration with the Drag and Spirituality Summit, to be held at Emmanuel November 1 to 3, 2024.

Hybrid Master of Divinity Program

Our Hybrid Master of Divinity (MDiv) program began this past year which allows for 2 years of a 3-year MDiv can be done online. We hope this will reach more prospective students outside of the Greater Toronto Area. Read this story about two folks who began the Hybrid MDiv this year.

Multi-faith Spiritual Life

Spiritual and religious activities thrive, in person every week, Tuesday and Wednesday. These sessions are led by Buddhist faculty members, guest religious leaders and our dedicated student Spiritual Life Team (SLT), along with students from Christian worship/preaching and Buddhist ritual courses. This SLT is enrolled in a year-long course for credit called "Worship and Ritual Leadership Practicum." Our Wednesday Spiritual Life Gathering continues to be the heartbeat of our week and alternates between Christian Worship and a Multi-faith Gathering. These gatherings are streamed live on YouTube and are open to the public and all are welcome!

Faith Community Partnerships

Over the past year and a half, we've been fortunate to receive community lunch sponsorships from various Christian, Muslim, and Buddhist faith communities. They've joined us at Emmanuel to share food, stories, and teachings about their faith traditions while learning from our students about their interfaith experiences. Addressing food insecurity is crucial today, and providing meals to our students in this manner has been a great blessing. If your church is interested in partnering with Emmanuel, please be in touch!

Financial Support

Emmanuel College continues to provide significant financial support to students. Through the John W. Billes Fund, Emmanuel continues to provide 100% of tuition coverage to all domestic students who are registered full-time in the M.Div. program and who are engaged in The United Church of Canada's candidacy pathway process. All basic degree domestic full-time students are eligible for our Entering Theological Education grant, which offers 50% tuition coverage to their first year courses. We also offer all (domestic and international) students who are registered in the Ph. D. program, 100% tuition coverage for four years. Rev. Elaine Kellogg




Those circles inspired Bedford House's Bridging Teams - small groups



He was born in July 1930 at Montreal, Quebec and died July 30 at Bowmanville Lakeridge Hospital in his 93rd year.


David was the adoptive son of Margaret and Dean McKinnell now

Jim spent his early years as a fisherman, postal manager and school



The Rules of Debate and Order

1. Presiding Officer

The function of the Presiding Officer is to preside, with all that that implies. The Presiding Officer should not attempt to control the decision of the Court but may express opinions on any matter before the Court. If the Presiding Officer wishes to introduce a motion or to present a report, the Presiding Officer shall ask another member to preside, and while out of the Chair shall be an ordinary member of the Court and must not assume the chair until the matter is disposed of. The Presiding Officer does not vote except in the event of a tie.

2. Questions of Privilege and Order

(a) A point of order may be raised while a matter is pending or while another member has the floor. When a point of order is raised it must be dealt with by the Presiding Officer without debate. If a member has the floor when a point of order is raised by another member, that member must yield the floor until the Presiding Officer has made a ruling.

(b) Any member of the Court may appeal from a ruling of the Chair, but only at the time when the ruling is made. But where a ruling is a precedent the general question of its correctness may be brought up later when there is no business pending, but cannot then affect the business transacted under the ruling.

(c) When an appeal from a ruling is made, the Presiding Officer should state the point at issue, and may give reasons for the ruling. The Secretary shall then put the question in the following form: "Is the ruling of the Moderator (or such other title by which the Presiding Officer is known) sustained?" If the vote is a tie, the Presiding Officer is sustained. The Secretary shall declare the result.

3. Orders of the Day

(a) When an agenda has been adopted that does not specify the time for its items, such items are considered without time limit, unless the Court decides otherwise by a two-thirds (2/3) majority of those voting.

(b) When an agenda has been adopted that specifies the time for particular items, such time shall be strictly adhered to, unless the Court decides otherwise by a two-thirds (2/3) majority of those voting. (2010)

4. Order of Priority on Motions

(a) To close (2010)

(b) To fix the time to adjourn.

(c) To adjourn.

(d) To take an immediate vote (two-thirds (2/3) vote required).

(e) To limit or extend limits of debate (two-thirds (2/3) vote required).

(f) To postpone definitely.

(g) To commit or refer.

(h) To amend.

(i) To postpone indefinitely.

(j) To deal with main motions.

5. Procedures on Motion

(a) A member of the Court proposes a motion.

(b) It is seconded. If there is no seconder, the motion fails.

(c) When the motion is duly moved and seconded, the Presiding Officer states the motion and declares it open for discussion. If the mover has not already done so, the mover has the right to introduce the discussion.

(d) A motion is out of order when it conflicts with a resolution previously passed at the same session unless it is a motion to reconsider.

(e) Without the permission of the Court, no member may speak more than once on any motion or on any amendment thereto.

(f) The mover of a motion has the right of reply before any vote is taken thereon or on any amendment thereto. Even when the Court has directed that an immediate vote be taken on a motion, the mover still has the right of reply.

(g) When a motion has two (2) or more clearly defined parts or points of issue, and any two (2) members request that it be divided, a separate vote must be taken on each part.

(h) Any motion may be withdrawn but only with the consent of its mover and seconder.

(i) After a motion is under consideration a question of order cannot be raised against it unless the motion is ultra vires.

6. Procedure on Amendments

(a) Any member except the mover or the seconder of the motion may move a relevant amendment thereto.

(b) An amendment must be seconded, and if there is no seconder it fails.

(c) A motion is amended by striking out certain words or clauses, adding certain words or clauses, or striking out all after the word "Resolved" (or the word "that"), and inserting another motion that will dispose of the matter. An amendment that merely negatives a motion before the Court is out of order.

(d) There may be an amendment to the amendment, provided it has been duly seconded.

(e) There is no limit to the number of amendments, but at any one time there can be before the Court only the motion, the amendment, and the amendment to the amendment.

(f) When an amendment is disposed of, other relevant amendments may be proposed.

(g) The discussion is always on the immediately pending question, and it must be voted on first. When a motion, an amendment, and an amendment to the amendment are before the Court, the two first named are "pending questions" and the last is the "immediately pending question." When the immediately pending question is disposed of, the one above it then becomes the immediately pending question, until the whole matter is disposed of. (h) When an amendment carries, it is not thereby adopted as the finding of the Court, but only changes the proposition under discussion.

(i) When a motion, an amendment, and an amendment to the amendment are before a Court, three (3) separate votes including "for" and "against" must be taken. The first determines whether the amendment shall be amended, the second determines whether the motion shall be amended, and the third determines whether the motion, in whatever form it is then before the Court, shall be adopted or rejected.

7. Procedure on Voting

(a) A vote is generally taken viva voce or by a show of hands. The Presiding Officer may ask for a standing vote. Upon motion duly passed, the vote shall be taken by ballot. In all actions of Church Courts regarding membership in the Order of Ministry requiring voting procedure, the vote shall be taken by ballot unless waived by unanimous consent; that is, on motion to waive, no dissenting vote is cast. See also sections C.5.7 and D.4.4 of the bylaws.

(b) In the event of a tie, the Presiding Officer shall cast the deciding vote.

(c) An affirmative vote on a motion does not validate any motion that is ultra vires of the Court, or that contravenes a decision of a higher Court.

(d) In the conduct of United Church business, voting by proxy or by mail-in ballot is not permitted. Voting by telephone or by email is permitted only when it occurs during a meeting that is held in a manner that allows all of the persons participating to communicate with one another simultaneously and instantaneously. (2010)

8. Procedure on Motion to Reconsider

(a) A motion to reconsider may be made at any time when the floor is vacant; but the actual reconsideration has only the same priority as the motion to be reconsidered.

(b) A motion to reconsider must be moved by a member who voted with the majority. Any member may second.

(c) If a motion to reconsider is dealt with at the same meeting in which the original motion was adopted, it will fail unless two-thirds (2/3) of those voting are in favour thereof. If a motion to reconsider is dealt with at a subsequent meeting of the Court, a majority of those voting determines the question.

(d) When any motion to reconsider has been duly seconded, all action on the original motion is suspended until the motion to reconsider has been disposed of. No motion to reconsider can be entertained by the Court where action has already been taken under the original motion.

(e) A motion cannot be reconsidered twice unless materially changed on the first reconsideration. If a motion to reconsider has been lost, it cannot be repeated.

(f) A motion to reconsider is debatable only when the motion to be reconsidered is debatable. It cannot be amended, postponed indefinitely, or committed.

9. Motion to Refer

A motion to refer is debatable, but only as to the wisdom and manner of the proposed referral. It requires only a majority of those voting.

10. Motion to Postpone Indefinitely

A motion to postpone indefinitely, when in order, must be put without debate. If the motion is lost, it cannot be repeated or reconsidered. If CARRIED, the motion along with all amendments is removed from debate. At any time, it may be brought back before the Court by motion duly seconded and CARRIED. In such case the question is before the Court in exactly the position it held at the time it was removed from debate. A motion to postpone indefinitely can have no conditions attached to it. If a time is specified, it immediately ceases to be a motion to postpone indefinitely and becomes a motion to postpone definitely and is debatable. (2007)

11. Motion to Take an Immediate Vote

If a motion to take an immediate vote (for which a two-thirds (2/3) vote is required) is CARRIED, the vote shall be taken immediately. The mover of the main motion, however, shall have the right to reply before the vote is taken. If such a motion fails, debate on the main motion shall continue. A motion to take an immediate vote is not debatable.

12. Motion to Adjourn

A motion to adjourn is intended to suspend a meeting until another time. A motion to adjourn is in order only if there is already an agreed-upon time and place for resuming the meeting, or if the motion specifies a time and place for resuming the meeting. A motion to adjourn requires a seconder. Only the conditions attached to the motion to adjourn, such as time and place for resuming the meeting, are debatable; the wisdom of adjourning is not debatable. (2010)

13. Closing a Meeting (2010)

(a) A motion to close is intended to terminate a meeting. A new meeting may commence, at a future time, by previous agreement or by call. There can be no conditions attached to a motion to close. A motion to close requires a seconder. A motion to close is not debatable. (2010)

(b) When all the business and purposes of a meeting have been attended to and the Presiding Officer is satisfied that there is no further business before the Court, the Presiding Officer may declare that the meeting is closed, without the need for a motion to close. (2010)

14. Committee of the Whole

(a) Any Court, for greater freedom of discussion, may, on motion duly made, seconded, and CARRIED, move into a Committee of the Whole. Any such motion is neither debatable nor amendable, except only as to the scope of the subject to be discussed. The motion is

not in order if there is a pending motion to adjourn the meeting or to postpone discussion on the subject. (2007)

(b) The first act of the Committee of the Whole is to appoint a chairperson and a secretary. A separate minute of the proceedings is taken. (2007)

(c) The ordinary limitations of debate do not prevail in the Committee of the Whole. The chairperson restates the matter(s) to be considered. Discussion is then opened and is conducted informally. Motions need not be seconded. Unless the resolution creating the Committee of the Whole imposes restrictions, there are no restrictions, within reason, on the number of times a member may speak or on the length of speeches, except that priority is given to a member who has not yet spoken. (2007)

(d) When the deliberations of the Committee of the Whole are concluded, the Committee will dispose of a motion that the Committee rise and report; this motion does not require seconding and is neither debatable nor amendable. When this motion is passed, a report is prepared and submitted to the chairperson of the main meeting, who reconvenes the main meeting. (2007)

(e) A Committee of the Whole can neither adjourn nor terminate; it only can report back to the main meeting. It can, of course, recess briefly to prepare its report. (2007)

15. General

(a) When a member utters language that another member considers offensive, the latter may require that the words be taken down. The speaker is then allowed to proceed. When the speaker yields the floor, the words complained of may be considered and dealt with. Such words may not be privileged.

(b) Members of any Court should at all times therein conduct themselves with dignity, fairness, and understanding. The prime concern should be the good order and welfare of the church.

(c) In any point not covered in The Manual, the parliamentary rules accepted in Canada (Bourinot) shall be followed.

Enabling Motions

1. <u>Regional Council Roll:</u>

That the Ministerial Roll of the Regional Council and the non-Ministerial Roll of the Regional Council thus constituted be now taken as read.

2. <u>Other Delegates</u>:

That anyone who has a role to play at the General Meeting of the East Central Ontario Regional Council (e.g. members of the Regional Council Assembly of Elders, Chairs of Leadership Teams and who has not been appointed as a delegate by her/his Community of Faith, be a full delegate with all the privileges of other delegates, and that the youth and young adult representatives from each Community of Faith be full delegates.

3. <u>Corresponding Members</u>:

That the students serving this Regional Council; the candidates for Ordination, Commissioning and re-Admission, those present as invited guests of this Regional Council, staff, resource persons, all who have registered for the Youth and Young Adult Event and other guests recognized by this court, be invited to sit as corresponding members of the Court.

4. <u>Minimum Number of Members at Meetings</u>:

That the minimum number of members for any session of this Regional Council is present (C.4.3, The Manual 2019).

5. <u>Agenda</u>:

That the agenda as printed and circulated, the reports, and the daily Agenda, be adopted as the Agenda for this meeting, subject to such changes as may be approved by this Court.

6. <u>Procedures for Reports</u>:

That the following procedure with respect to reports being presented at the Regional Council be adopted.

- a. Reports and any attendant recommendations be dealt with in the allotted time.
- b. If action has not been completed in the allotted time, then the Regional Council may:
 - i. Request that additional time on the Agenda be arranged by the Business Leadership Team
 - ii. Refer the report with its recommendation(s) to the appropriate body or bodies concerned, along with power to issue
 - iii. Refer the report with its recommendation(s) to the Assembly of Elders of the Regional Council for such action as the Assembly of Elders deems appropriate.

7. <u>Meeting of the Assembly of Elders</u>:

That the Assembly of Elders (which is empowered to act on behalf of the Regional Council between the meetings of the Court) be empowered to meet, if necessary, during the sessions of this Regional Council meeting and report those matters which require the approval of this Court.

8. <u>Inclusive Language</u>:

It is recommended that every attempt be made to use inclusive language in all worship, reports, petitions and discussions in this Court.

9. <u>Business Leadership Team</u>: That the *Business Leadership Team* be members from the Facilitation Team

10. <u>Scrutineers/Stewards</u>: That the *Scrutineers/Stewards* be members of the tech team.

Purpose: The purpose of this policy is to clarify limits of the budget process. The Manual C.2.5.		

Preamble

This document outlines the East Central Ontario Regional Council's policy and best practices regarding requests for funding outside of the approved annual budget at the annual meeting.

Policy

It is the policy of East Central Ontario Regional Council to affirm and uphold the use and function of the Business Committee for matters coming to the floor of the Annual Meeting of the Regional Council.

It is the policy of East Central Ontario Regional Council that any motion committing the East Central Ontario Regional Council to the expenditure of non-budgeted sums of money be required to have a budget attached;

It is the policy of East Central Ontario Regional Council that any motion committing the East Central Ontario Regional Council to non-budgeted expenditures which are presented during the Annual Meeting be automatically referred to the Assembly of Elders who may request input from the Mission through Property Leadership Team first before making the decision;

It is the policy of East Central Ontario Regional Council that in the interests of fairness and justice, requests for funding of projects or groups not covered in the existing financial budgets be subject to conditions and criteria similar to those that are currently expected of requests for Mission Support, and other funds available within the Regional Council.
