Appendix A

Increasing Participation and Involvement in the Regional Council's work

Following the December meeting of the Council of Elders and the discernment conversation that took place at that time, the staff team have provided the following measures we are taking to address this issue:

- 1. The Connectors will be reaching out to the communities of faith for which they are responsible to check in and see what, if anything, is preventing participation from their representatives and ministry personnel. They will report back to the Council of Elders and the Facilitation Forum.
- 2. A short, one-page summary of our meetings will be shared with Regional Council members after each meeting, which will enhance their ability to share information with their communities of faith.
- 3. A report will be prepared by the Regional Council that can be easily included in Annual Reports at the congregational level.
- 4. The Annual Report Book will be shared with all congregations and we are exploring an info-graphic for progress on the Strategic Plan.
- 5. Lynn Watson has agreed to prepare a worship service that can be used by congregations on the Sunday that follows Regional Council meetings. When the service is shared with congregations, a note will be included to ensure that they are aware that they should not be expecting their ministry personnel to lead worship on Regional Council weekends.
- 6. Consider an annual orientation meeting for new representatives to the Regional Council (both clergy coming into our region and new reps that were elected at their congregational meetings).
- 7. Prepare a set of short videos that help explain the role of Regional Council members, how things work.

We will explore other possible actions once we have heard back from Connectors and see how this approach impacts involvement.

Dear Mr. Nater.

I am writing today with deep concern about the impact of recent changes to the Temporary Foreign Workers policy on small rural churches. Without a minister to oversee the day-to-day operations of these small non-profit organizations and offer the services that generate the donations they need to support their work, many small rural churches have to close. As an increasing number of small rural churches find that the only applications they receive are from international ministers, increased restrictions around immigration will result in some small rural churches having to close because they can't hire qualified professionals without undue stress resulting from delays and denials by Immigration Canada. I assume that wasn't the government's intent and I wonder if, after considering my concern, you might be willing to speak to the Ministers of Immigration, Refugees, and Citizenship about this matter.

I'm concerned about this reality because I work remotely from my home in Listowel as coordinator of the Admission program of The United Church of Canada. The Admission program provides a robust selection and orientation process through which churches in hamlets like Alma to the east of us and Pine River to the west of us have found a minister in recent years.

In rural areas like these, the ministry of these leaders reaches beyond the local church out into the community. The community may turn to them for spiritual care in the nursing home, to officiate a wedding or funeral service for a community member, to hand out food hampers when someone is hungry in the community, when a community group needs a low to no cost meeting space, if a person needs help with addictions or leaving a situation of domestic violence, etc. They are also a person that small communities with few other professionals rely on when a tragedy occurs and people need support.

Yet all too often lately, after carefully and prayerfully selecting an international minister, the excitement for our rural churches turns to frustration as their new minister encounters delays and denials in their conversation with Immigration Canada. This week for example, I heard from a church in northern British Columbia who selected their new minister in July 2024 and prepared for them to arrive in October 2024 given the three month timeline then in place; they have now been waiting six months and are worried about their viability given that they are paying out \$2000 a month to maintain the rental home they found and furnished for their minister even though nobody is living in it and their donations are down significantly because they have no minister there to offer services. Where it used to be the exception that we needed to seek legal counsel to help in a situation like this, it has now become the exception if we don't need to seek legal counsel to help congregations get their new minister's visa approved.

I know you will share my concern because this reality does not align with the Immigration Principles outlined in the Conservative Party of Canada's Policy Declaration. That document states clearly that the CPC values "a non-partisan, welcoming and well managed immigration system for Canada". It further expresses that this system should offer a "a fair, transparent and efficient process that earn(s) the respect and confidence of Canadians as well as the international community" and "ensur(es) that Canada is successful in encouraging skilled

immigrants and their spouses and children to make Canada their destination of choice". Given the CPC's values around immigration and your own commitments to the vitality of rural communities, I wonder if you might be willing to raise this issue with the Honorable Marc Miller?

Trusting you will respond favorably to my request, I have attached a copy of a letter The United Church of Canada sent to Mr. Miller a month ago now as further background into the issues we have observed, particularly in response to recent changes to the Temporary Foreign Workers Program that our churches use when they select an international minister. That letter not only outlines our concern, but also offers two solutions. We are asking government to:

- 1) **Institute an immediate carve out to create an exception for clergy coming into Canada** through programs such as the United Church of Canada's Admission program.
- 2) Rethink the reforms to Canada's immigration policy and make Canada more, rather than less, open to immigrants. Clergy from other denominations who immigrate to Canada as temporary foreign workers are just one example of the many ways in which (im)migrants make important contributions to the fabric of Canadian society.

Thank you for your ongoing care and commitment around the vitality of rural communities in this riding and across the country. I know that you will understand the important role that small rural churches have in these places and the great loss it can be for a community to lose one. Your response to my request to help us protect these churches by not letting current immigration practices hamper their ability to find suitable, professional leaders is appreciated. I would be grateful if you could keep me informed of the steps you take and any results they might inspire.

Don't close our churches!

A guide to write about the need for a more expansive Temporary Foreign Worker (High Income Stream) program. This program includes United Church of Canada admission ministers and as a result of changes to the program they are now being negatively affected by Canadian government changes to migration rules.

Why we write

Canadian politicians are elected by us and they know that in order to continue doing their jobs they need to effectively represent the people of their riding. It is within our power as individuals to share our opinions and expect governmental action on our subjects of concern.

In this particular case churches who are not able to welcome an admission minister or who are at risk of losing their minister because of the program changes may need to close and will cease supporting their communities. Your MP will want to know about how their community will suffer as the church and minister cease to provide services.

If you are part of the process who screens and welcomes admission ministers your MP will want to know why you do this work and the benefits that you see these ministers providing to Canada as whole even if the church is not in their riding.

How to write

Be Clear!

We are asking the government to:

- 1. Institute an **immediate carve out** to create an exception for clergy coming into Canada through programs such as the United Church of Canada admission process.
- 2. Rethink the reforms to Canada's immigration policy and make Canada more, rather than less, open to immigrants. Clergy from other denominations who immigrate to Canada as temporary foreign workers are just one example of the many ways in which (im)migrants make important contributions to the fabric of Canadian society.

We are asking this because they have recently changed the rules which is making it more difficult for approved admission ministers to come to Canada and for ministers currently here to have their permits renewed. These expectations include:

- 1. A requirement for the employer to have three full-time Canadian staff
- 2. The newly increased pay rate threshold for the Temporary Foreign Workers Program High Income Stream is above what some clergy would receive as take-home pay due to our practice of providing housing, especially in location where admission ministers are welcomed.
- 3. Meeting a minimum financial requirement that is not realistic for clergy who do not amass financial assets or own property as housing is often provided
- 4. Specific countries have had the number of people coming from them capped and that may not be known or obvious as the United Church of Canada process considers potential candidates

Be persuasive!

- Write an original letter using your own words (Use the sample letters written by Sarah Bruer and the official letter sent to Minister Miller by the Moderator and General Secretary as guides)
- If you are able, write it by hand on distinctive letterhead or print it out and mail it. It will get more notice that way.
- If email is what you can manage, by all means do that instead use a catchy subject line "Don't close our church!"
- Invite them into relationship with you and tell them about your relevant experience that might resonate with them. (A brief Google search will tell you a bit more about them and you may find commonalities if you do not know them yet)
- State the purpose of your letter and then detail your concerns, including how they affect you and your community
- Share our two requests found above
- Thank them for any action they have already take on this or related issues
- Ask them to be in touch with Minister Miller about your concerns
- Ask them to get back to you with a response
- Close your letter in a cordial manner

Be focused!

- Keep your letter concise one to two pages is best. You can attach or include the longer United Church of Canada letter if you want to provide more background
- Share your letter with someone who knows little about the subject. Do they understand it? Is it compelling? Strengthen it as needed

Be complete!

- Include your full contact information
- Date the letter
- Address the letter to your MP

Appendix D²

Services Offered through National Program

- 1. GCO will receive and read all material required from the incorporated ministries
 - Minutes of board meetings
 - Minutes of annual meeting
 - Financial statements audited or independently reviewed
 - Membership of the board OR
 - Proposed board nomination list for approval
 - Evidence of insurance coverage including naming of The United Church of Canada as additional insured
- 2. GCO will follow up with the IM's as necessary
 - Indications where follow-up is required may include: lack of reporting, incomplete information, etc.
 - Such follow-up would be via email and/or phone call
- 3. GCO will communicate with the regional councils immediately if there is a significant issue that needs to be addressed
 - Indications where follow-up is required by the region would be anything related to the supervisory role of the region. Examples may include: failure to make quorum, failure to meet, concerns identified in board minutes, financial statements, annual report or similar related reports.
- 4. GCO will review the financial statements
 - Any concerns that may be identified from the review will be communicated to the regional council
- 5. GCO will prepare a report, as required, for all motions requiring approval by the regional councils as the supervising court. Such motions would include:
 - Approve majority of directors
 - Approve capital fundraising initiatives and appeals
 - Indebtedness levels as may be required within the corporation's by-laws
 - Consent to sale, transfer, mortgaging, acquisition or leasing of land
 - Consent to the voluntary winding up of the corporation
 - Change or modifications to by-laws (UCC requirements)
 - Changes to articles of incorporation
 - Any other items requiring approval as may be included in the corporate by-laws
- 6. GCO will maintain a database to track receipt of reporting
- 7. GCO will review the by-laws and advise the regional council when they are ready for approval
- 8. GCO will consolidate and maintain all corporate files
 - Regional councils will have access to files via a digital mechanism
- 9. GCO will be the lead for all Release Agreements
- 10. GCO will take the lead for all Legacy Agreements that the Regional Council brings forward
