The Role of the Office of Vocation

- The Office of Vocation is served by several committees including:
 - The Board of Vocation
 - The Candidacy Boards
 - The Credentialling Committee (Interim/Ed. Supervisor)
 - The Response Committee
 - The Remedial Committee

The Role of the Office of Vocation

The Office of Vocation focuses on ministry personnel at all stages.

This includes:

- Entering Ministry/Candidacy
- Specializing (Interim Ministry or Educational Supervision)
- Active
- Retired



The Office of Vocation is served by Vocational Ministers who:

- serve the as the Staff Resource for the Candidacy Boards
- serve as a resource and support to ministry personnel involved in our complaints process, either as the complainant or respondent
- facilitate ministry personnel in completing mandatory requirements such as annual declarations, boundaries courses and racial justice training

Annual Declarations

- To be listed in the registry of accredited ministry personnel, a minister must be up to date with mandatory training in boundaries (every 5 years) and racial justice; and be up to date with Annual Declarations.
- Annual Declarations: each year, we ask all ministry personnel, active and retired, to take a few minutes to confirm that they have a current police record check and to confirm their status with respect to criminal charges.
- The deadline this year is June 30, 2025.
- To submit your declaration, please visit your Church Hub profile page under "My Ministry".

The Office of Vocation is served by Vocational Ministers who:

- serve as a conversation partner to clergy who are wrestling with an ethical issue
- explore together the Ethical Standards for Ministry Personnel
- explore together the Creating Safe and Respectful Environments policy

To offer pastoral support to ministry personnel who are experiencing challenges in their ministry that they feel might escalate into a formal complaint.

Sometimes, as an outcome of the complaints process, a minister is required to participate in directed learning. The Vocational Minister:

- help create personalized learning plans to support them.
- stay connected with them as they work through the plan, offering guidance and encouragement where needed.
- find qualified and trusted volunteers who walk alongside the minister during this time, offering support and feedback.

To offer pastoral support to ministry personnel who are discerning:

- Whether they are hearing a call to retirement or to come out of retirement
- Whether it's time to transition to a different ministry, (for example, to bivocational ministry or to imagine a new kind of ministry) or to leave ministry all together (i.e. join the Discontinued Service List Voluntary)

What else does a Vocational Minister do?


Celebrates!
